**ORDINANCE ADOPTING THE SIX-YEAR CAPITAL IMPROVEMENT PROGRAM (CIP) FOR WHATCOM COUNTY FACILITIES (2021-2026) AND REPEALING THE SIX-YEAR CIP FOR WHATCOM COUNTY FACILITIES (2019-2024) (AB2020-447):** This ordinance adopts the Six-Year Capital Improvement Program (CIP) for Whatcom County Facilities (2021-2026) and repealing the Six-Year CIP for Whatcom County Facilities (2019-2024). The Six-Year Capital Improvement Program (CIP) for Whatcom County Facilities addresses County parks, trails, activity centers, maintenance & operations, general government buildings and sites, Sheriff's Office, emergency management, adult corrections, juvenile detention, transportation, and stormwater facilities. This ordinance was introduced on October 27, 2020.

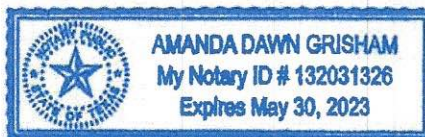
