

We are providing the following details in compliance with the 30-day advanced notification of an adjustment to rates under the applicable FCC regulations and the requirements of our franchise with the County of Whatcom County, Wave Broadband will be adjusting the retail price of some of its video services starting February 1, 2020.

The monthly rates for the following TV services will be adjusted: the Local TV Stations' fee will increase by \$0.58; Local Broadcast TV, and any packages including that service, will increase by \$2.00; the Expanded Content channel tier (also known as Basic Cable), and any packages including that service, will increase by \$1.35. Digital Channel tiers including Digital Favorites, Digital Variety and Digital Sports tiers, and any packages including these services will increase by \$1.00 each. Universal and Digital Converter set-top boxes, HD Receiver set-top boxes, High Definition DVR set-top boxes, TiVo DVRs and TiVo Minis will increase by \$1.00 each.

This rate adjustment is the result of annual programming cost increases by major TV networks, regional sports programmers, independent channel providers, and local broadcast channel providers. When network owners increase their monthly fees, it ultimately results in higher rates for our video customers.

These rate changes are exclusive of franchise fees, regulatory fees, and other governmentally-imposed charges. Customers will receive the accompanying letter with detailed information covering the rate changes with their billing statement.
