HEMMI ROAD AT THE INTERSECTION WITH HANNEGAN ROAD 7 8 9 WHEREAS, the Whatcom County Council is authorized under RCW 46.61.290 to establish restrictions on vehicular movements on certain County Roads; and 10 11 WHEREAS, the Meridian School District has requested that left turn and through 12 movement restrictions be established on E. Hemmi Road at the intersection with Hannegan 13 Road, during the school year; and 14 15 WHEREAS, these restrictions are being established to facilitate a safer and more 16 17 orderly flow of traffic; and 18 19 WHEREAS, the County Engineer has agreed that it is necessary to formally establish 20 these restrictions; and 21 NOW, THEREFORE, BE IT ORDAINED by the Whatcom County Council that the 22 23 restrictions be established as follows: 24 25 1) Left Turns shall be prohibited from westbound E. Hemmi Road to southbound 26 Hannegan Road from 8:30 am to 10:30 am and 3:00 pm to 4:30 pm, during the school year, located in Sections 16, 17, 20 and 21, Township 39 North, Range 3 27 28 East, W.M. 29 2) Through Movements shall be prohibited from westbound E. Hemmi Road to 30 westbound E. Hemmi Road at the intersection with Hannegan Road from 8:30 am 31 to 10:30 am and 3:00 pm to 4:30 pm, during the school year, located in Sections 32 16, 17, 20 and 21, Township 39 North, Range 3 East, W.M. 33 34 BE IT FURTHER ORDAINED, by the Whatcom County Council that the following be 35 added to Whatcom County Code Section 10.48: 36 37 10.48.020 LANE RESTRICTION - LEFT TURN MOVEMENTS ON E. HEMMI ROAD. 38 E. HEMMI ROAD. Left Turns shall be prohibited from westbound E. Hemmi Road to 39 southbound Hannegan Road from 8:30 am to 10:30 am and 3:00 pm to 4:30 pm 40 during the school year, located in Sections 16, 17, 20 and 21, Township 39 North, 41 Range 3 East, W.M. 42 43 10.48.030 LANE RESTRICTION - THROUGH MOVEMENTS ON E. HEMMI ROAD. 44 E. HEMMI ROAD. Through Movements shall be prohibited from westbound E. Hemmi 45 Road to westbound E. Hemmi Road at the intersection with Hannegan Road from 46 47 8:30 am to 10:30 am and 3:00 pm to 4:30 pm during the school year, located in 48 Sections 16, 17, 20 and 21, Township 39 North, Range 3 East, W.M.
