## WHATCOM COUNTY SEXUAL ASSAULT AUDIT, PUBLISHED 2019 FINDINGS: THEMES, STRENGTHS, & GAPS

#### **OVERARCHING THEMES**

- 1. The ways our community institutions understand and respond to reports of sexual assault are influenced by widespread societal myths and misconceptions about sexual assault.
- Implicit bias and historical oppression lead to inequitable outcomes in the ways our community institutions serve and partner with marginalized communities, particularly Native communities.

#### **IDENTIFIED STRENGTHS**

- 1. Bellingham and Whatcom County agencies pro-actively committed to the intensive Audit process to examine our limitations and improve our systems responses, in order to seek justice for sexual assault survivors, accountability for offenders, and increased community safety.
- 2. Bellingham and Whatcom County agencies have functioning commitments to and frameworks for multidisciplinary collaboration and response to sexual assault cases.
- 3. The expertise and effort of individual practitioners in sexual assault dynamics and traumainformed care contributes to survivors' experiences of being believed, and increase survivors' sense of justice, dignity, and safety following a sexual assault.

#### **IDENTIFIED GAPS**

- 1. There are systemic delays in processing sexual assault cases.
- 2. Sexual assault survivors experience a lack of follow-up, communication, and engagement from responding systems.
- Institutional responses to reports of sexual assault are overly reliant on assessing survivor credibility—more so than suspect behavior and credibility.
- 4. There is a lack of criminal accountability for reported sexual assault offenders in our community, which includes and may enable serial offenders.
- 5. Across systems, there is lack of expertise in sexual assault dynamics, trauma-informed care, and effective survivor engagement.

### quotes from survivors of sexual assault

"If nothing else were to change, it is that you need to tell the victim what is going on."

"There are so many missed opportunities by many people in power to even acknowledge harm done, to offer condolences."

"Sometimes the way agencies respond, or don't respond to you ends up actually being worse of an experience than the incident."

### Whatcom County Sexual Assault Audit

- Data collected in 2017 and 2018 by multi-disciplinary team
- Data collection activities included:
  - Focus groups & interviews with survivors
  - Focus groups & interviews with professional stakeholders
  - Mapping of systems responses
  - Text analysis (agency policies and procedures, police reports, prosecution files)
  - Observations (trial, emergency department processes, MDT meetings)

### Whatcom County Sexual Assault Audit

### <u>Findings – Themes</u>:

- Societal myths and misconceptions about sexual assault
- Implicit bias and oppression, particularly impacting Native survivors

### <u>Findings – Gaps</u>:

- Delays
- Lack of follow-up and communication
- Over-focus on survivor credibility
- · Lack of criminal accountability & serial offenders
- Lack of expertise trauma-informed responses

Youth Summit for high school youth groups with an adult mentor Friday, March 1, 2019

#### Who participated?

- 145 students
- 24 adult mentors/team leaders
- 8 high schools, Juvenile Detention, home school, Nooksack youth program
- Groups included: sports teams, prevention clubs, QSAs
- 74% identified as female, 18% as male, 8% as non-binary
- 44% of students identified as LGBTQ+

IF IT'S NOT CLEAR, IT'S NOT CONSENT.

82 students completed evaluations (57% response rate)

### What did they learn?

- 99% learned how to define consent
- 96% learned how to recognize consent
- 89% learned about new resources
- 95% felt energized to take action
