COUNCIL ACTION PROPOSED The Whatcom County Council will consider adopting and may amend the following at its May 21, 2019, meeting: ORDINANCE AMENDING THE 2019 WHATCOM COUNTY BUDGET, REQUEST NO. 7, IN AB 2019 - 263
THE AMOUNT OF \$907,787 (AB2019-263): This ordinance adds appropriations to the following budgets: \$783,500 to Sheriff \$8,931 to Non-Departmental; \$20,000 to Veteran's Relief Fund; \$41,000 to Behavioral Health Programs Fund; and \$54,356 to Public Utilities Improvement (EDI) Fund, for a total supplemental amount of \$907,787. ORDINANCE AMEND-ING THE PROJECT BUDGET FOR THE PUBLIC SAFETY RADIO SYS- AB 2019-265 TEM FUND, REQUEST NO. 1 (AB2019-265): This ordinance adds \$54,356 of expenditure authority to the project budget of \$96,802 for a total amended preliminary project budget of \$451,158. ORDINANCE AMEND-ING WHATCOM COUNTY CODE TITLE 3, REQUIRING THAT PUB-LIC FUNDS USED FOR CON-STRUCTION PROJECTS DO DOU-BLE DUTY BY ALSO PROVIDING APPRENTICES WITH JOB TRAIN-ING HOURS TO MEET THE RE-QUIREMENTS NECESSARY TO BECOME THE NEXT GENERA-TION OF SKILLED TRADES PER-SONS [AB2019-285]: This ordi AB2019 - 285 nance amends Whatcom County Code to include a new chapter "Construction Projects - Apprentice Requirements" that requires that pubfic funds used for construction projects do double duty by also providing apprentices with job training hours to meet the requirements necessary to become the next generation of skilled persons.
