COUNCIL ACTION TAKEN

The Whatcom County Council adopted the following at its July 9, 2019, meeting: ORDINANCE (2019-049) IMPOSING AN INTERIM MORATORIUM ON THE ACCEPTANCE AND PROCESSING OF APPLICATIONS AND PERMITS FOR NEW OF EXPANDED FACILITIES IN THE CHERRY POINT URBAN GROWTH AREA THE PRIMARY PURPOSE OF WHICH WOULD BE THE SHIPMENT OF UNREFINED FOSSIL FUELS NOT TO BE PROCESSED AT CHERRY POINT (AB2019-339): This interim moratorium prohibits the filing, acceptance, and processing of new applications for conversion of land or water, new building or structure permits, or other County permits or authorizations in the Cherry Point Urban Growth Area for new or expanded facilities whose purpose is to facilitate the increased shipment of unrefined tossi fuels not to be processed at Cherry Point, unless the applica-tions: 1. Were filed and complete prior to the effective date of this ordi-nance and vested pursuant to Washington statutes; 2. Were for building permits for remodels, maintenance, or repairs of existing structures where no increased capacity for shapping unrefined fossil fuels not to be processed at Cherry Point will result; or 3. Were necessary to protect health and safe ty of the community. This interim ordinance shall be effective for not longer than six months following its effective date, but may be renewed for one of more six month periods if subsequent public hearings are held and findings more sx-month periods it subsequent public hearings are neigh and radings of fact are made prior to each renewal. The previous franchises granted to Deer Creek Water that pertain to water lines for the provision of water services shall be terminated and be replaced by this franchise.
