Whatcom County Council adopted the following at its November 19, 2019, meeting: ORDINANCE (2019-079) AMENDING WHATCOM COUNTY CODE TITLE 3, REQUIRING THAT PUBLIC FUNDS USED FOR CONSTRUCTION PROJECTS DO DOUBLE DUTY BY ALSO PROVIDING APPRENTICES WITH JOB TRAINING HOURS TO MEET THE REQUIREMENTS NECESSARY TO BECOME THE NEXT GENERATION OF SKIL-LED TRADES PERSONS (AB2019-285): This ordinance amends the Whatcom County Code to include a new chapter "Construction Projects -Apprentice Requirements" that requires that public funds used for construction projects do double duty by also providing apprentices with job training hours to meet the requirements necessary to become the next generation of skilled persons. This ordinance was introduced November 6, 2019. ORDINANCE (2019-075) AUTHORIZING THE LEVY OF TAXES FOR COUNTYWIDE EMERGENCY MEDICAL PURPOSES FOR 2020 (AB2019-542): This ordinance limits the amount collected through the Countywide Emergency Medical levy to be limited to the amount of 2019 taxes, in creased for the addition of new construction and improvements to property and any increase in the value of state assessed property. A property tax in crease, in addition to the amount resulting from the addition of new construction and improvements to property and any increase in the value of state-assessed property, is authorized for the 2020 levy in the amount of \$0, which is a percentage increase of 0% from the previous year. This ordinance was introduced November 6, 2019. ORDINANCE (2019-076) AUTHORIZING THE LEVY OF TAXES FOR CONSERVATION FUTURES PUR-POSES FOR 2020 (AB2019-543): This ordinance, pursuant to Home Rule Charter Section 6.10, states that the amount collected through the County Conservation Futures levy shall be limited to the amount of 2019 taxes, increased for the addition of new construction and improvements to property and any increase in the value of state assessed property. A property tax increase, in addition to the amount resulting from the addition of new construction and improvements to properly and any increase in the value of state-assessed property, is hereby authorized for the 2020 levy in the amount of \$0, which is a percentage increase of C% from the previous year. This ordinance was introduced November 6, 2019. ORDINANCE (2019-077) AUTHORIZING THE LEVY OF 2020 PROPERTY TAXES FOR COUNTY ROAD PURPOSES (AB2019-544): This ordinance, pursuant to Home Rule Charter Section 6.10, states that the amount collected through the County Road levy shall be limited to the amount of 2019 taxes, in creased for the addition of new construction and improvements to property and any increase in the value of state assessed property. A property tax increase in addition to the amount resulting from the addition of new construction and improvements to property and any increase in the value of state as-sessed property is hereby authorized for the 2020 levy in the mount of \$0. which is a percentage increase of 0% from the previous year. This also authorizes diverting \$806,530 of the County Road District levy for the budget year 2020 to the General Fund. Diverted County Road Taxes are to be used year 2020 to the General Fland. Underted County robat laxes are to be asset for traffic law enforcement in the unincorporated areas of Whatcom County. This ordinance was introduced November 6, 2019. ORDINANCE (2019-078) AUTHORIZING THE LEVY OF TAXES FOR COUNTY AND STATE PURPOSES IN WHATCOM COUNTY, WASHINGTON, FOR THE YEAR OF 2020 (AB2019-547): This ordinance states that the amounts collected through the County general levy shall be limited to the amount of 2019 taxes increased for the addition of new construction and improvements to property and any increase in the value of state assessed property. The taxes to be levied against parcels of property within the Diking Districts, Drainage Districts, and Drainage Improvement Districts are to be credited to the individual maintenance funds for the year 2020, and the amounts to be apportioned to the original assessments for construction in said districts per Exhibit B of the ordinance.
