Dear Mr. Browne:

I am writing this letter to express my objection to Resolution 2019-35 to create a non-shooting zone in and around Drayton Harbor. There has been hunting on Drayton Harbor and worldwide for centuries, even before man was on earth. In recent times hunting has become legalized and regulated and has an outstanding safety record. Hunting is a management technique for controlling bird populations thus preventing the spread of disease (especially to humans), overpopulation that leads to the destruction of habitat and a natural balance in nature.

Firearm noise from hunting is protected by WAC 173-60-050 (4)(j) and should not be considered an issue in supporting Resolution 2019-35. Firearm noise is more of a personal discomfort for a limited number of people in the vicinity, it is not a threat to their health or wellbeing.

Hunters have a long history of supporting conservation in North America. Many believe, "Hunters are considered waterfowl's best friend".
