The first 17 and a half years of my occupation was spent on Lummi Island. There I learned to commercially fish and be a home builder.</p> <p>These are the trades which I have engaged throughout my life here in Whatcom County.</p> <p>While I lived on the island, from which I attended Ferndale High</p>

and education

School , I often engaged community meetings and tough discussions that concerned our community.  
I believe I have a unique perspective of the changes that the island has gone through over the last four decades.  
And while I no longer live on the island, I maintain strong community ties there, and have often participated in further community conversations that affect that community.  
In many ways, I still identify as a Lummi Islander. It doesn't just leave you.  
Many of my closest friends and confidants live there.  
In my time away from the island I have been very very active in community service to Whatcom County, having also served on the homeless strategies work group from 2019 through 2021.  
I was appointed in a 6 to 1 vote by County Council in 2019, and was happy to be unanimously reappointed in 2020.  
I was very active in that group, and helped to make some very impactful changes in our community from that position.  
I'm very proud of that work.  
I've also served on the board of two different nonprofits regarding local homelessness, and have brought to fruition, many different helpful strategies to help us cope with this ongoing issue in our community. I still maintain a great deal of service here as well.

8. Please describe why you're interested in serving on this Advisory Group.

Esteemed County Council members,  
Over the last 40 years I have observed many changes on Lummi Island.  
I have seen the demographics change there drastically.  
In short, the people who built the island, cannot afford to live there.  
And while it could be argued that there has been some benefit to the island through what many of us might see as gentrification, as a great location to retire and rather be away from a madding world, the vibrant community that once was there, has suffered greatly due to rising costs of ferry fares, taxation, and a changing political and resource related climate.  
And, like myself, many of those community members who were part of its vibrant culture and community, have been forced to move on, largely because of the growing expense of living on that island.  
I still have many friends there who, once they got their mortgage together, suddenly felt chained to that property that they were rather suddenly unable to otherwise afford, as these changes took hold.  
It's my goal to acknowledge and give voice to those changes, and those disaffected community members, as well as hear the voices of those community members who feel that it is a more livable and happier place because of those changes.  
I identify with the island so strongly, I simply want to see it be represented and representative of the people who live there, and I believe my unique skill set, an intimate familiarity with the community serve that purpose.
