Whatcom County Council will have a public hearing, consider adopting, and may amend the following at its March 24, 2020, meeting, or at a later date: **ORDINANCE GRANTING CELLCO PARTNERSHIP d/b/a VERIZON WIRELESS, A NON-EXCLUSIVE FRANCHISE FOR THE PROVISION OF WIRELESS TELECOMMUNICATIONS SERVICES (AB2020-086)**: This Ordinance grants a franchise to Celco Partnership d/b/a Verizon Wireless, allowing it to enter, use, and occupy all Rights-of-Way within current and future unincorporated Whatcom County for the installation, maintenance, operation, repair, modification, replacement, and/or removal of such small wireless facilities for the provision of wireless telecommunications services per the term of the franchise agreement, under RCW 36.55 and 9.30 of the Whatcom County Charter. Council introduced above at its February 25, 2020, meeting. 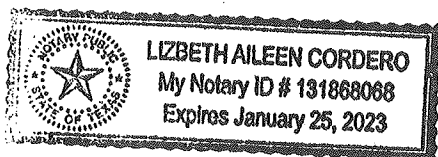
