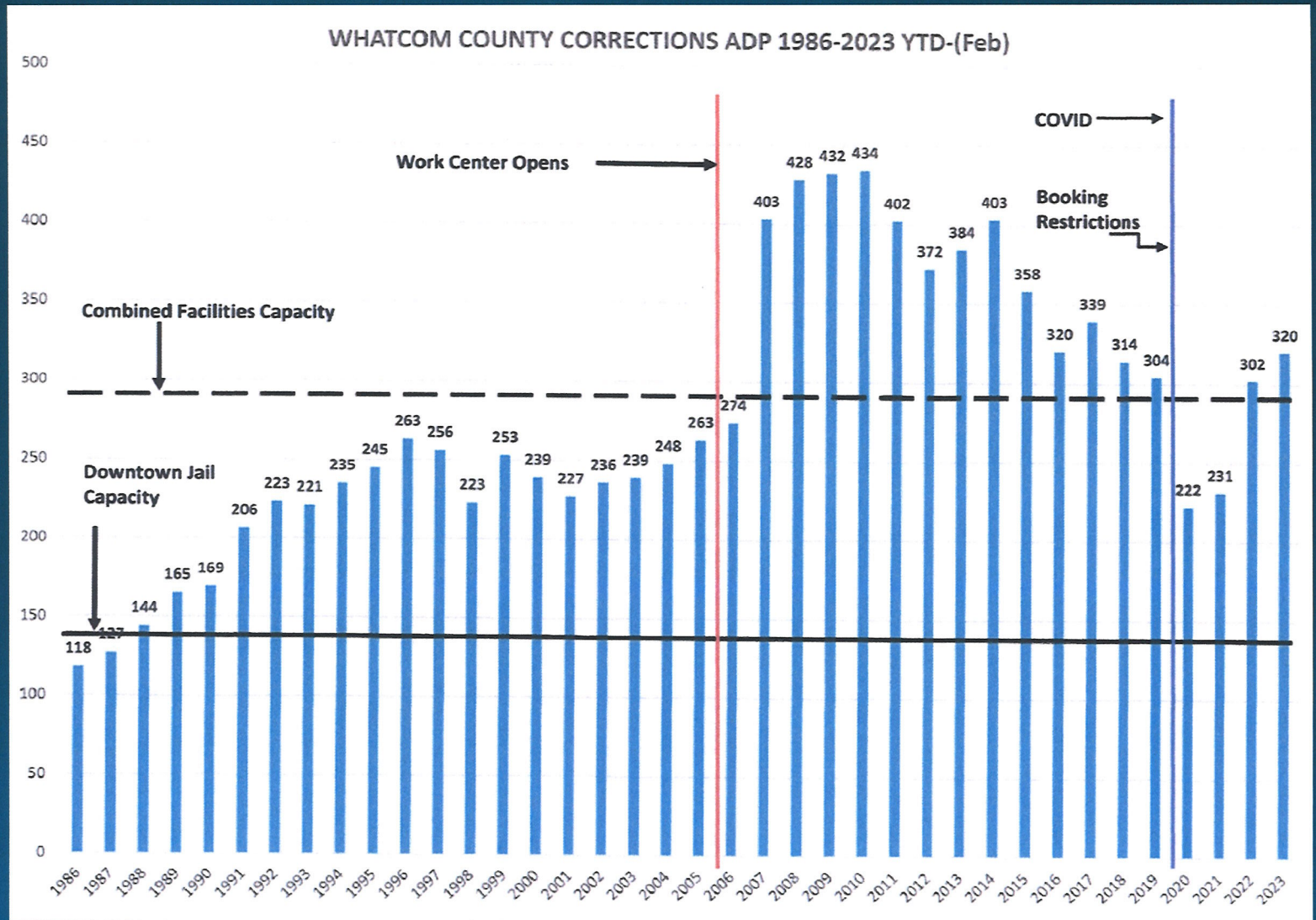


# Who is in Jail

# Daily Snapshot — 4/24/23 – 5/1/23

- 325 - Avg. daily population in jail
  - 191 in Main Jail on 5/1/23
  - 103 in Work Center on 5/1/23
- 19 on Electronic Home Detention (EHD)
- Additional 35 people on District Court Monitoring Program



# Daily Snapshot – 4/24/23 – 5/1/23

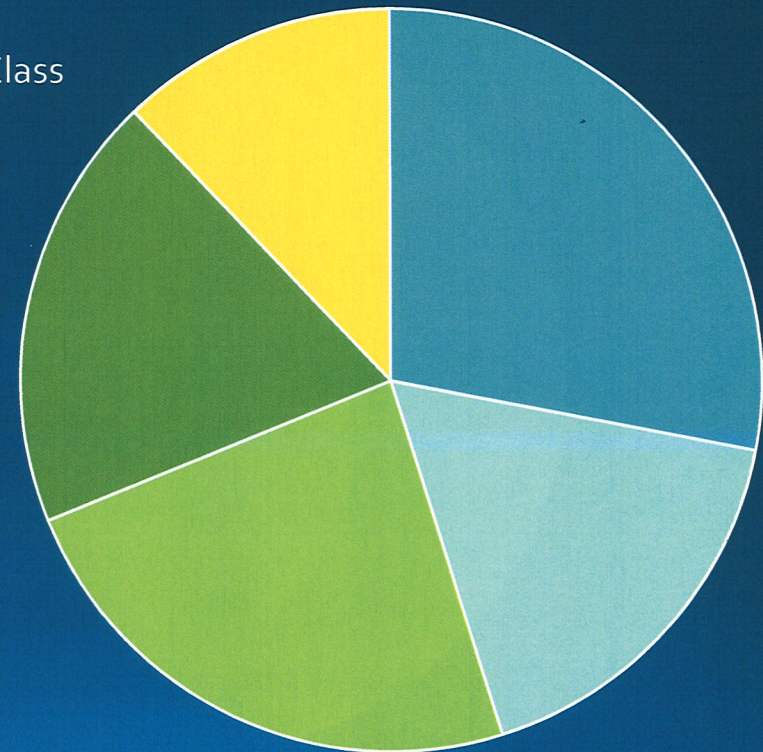
- 90% of people booked and held in custody have at least 1 felony offense
- 90% are being held pre-trial after judicial review
- ~50% have mental illness
- ~80% have substance use disorder
- 22 people awaiting competency restoration on 5/1/23

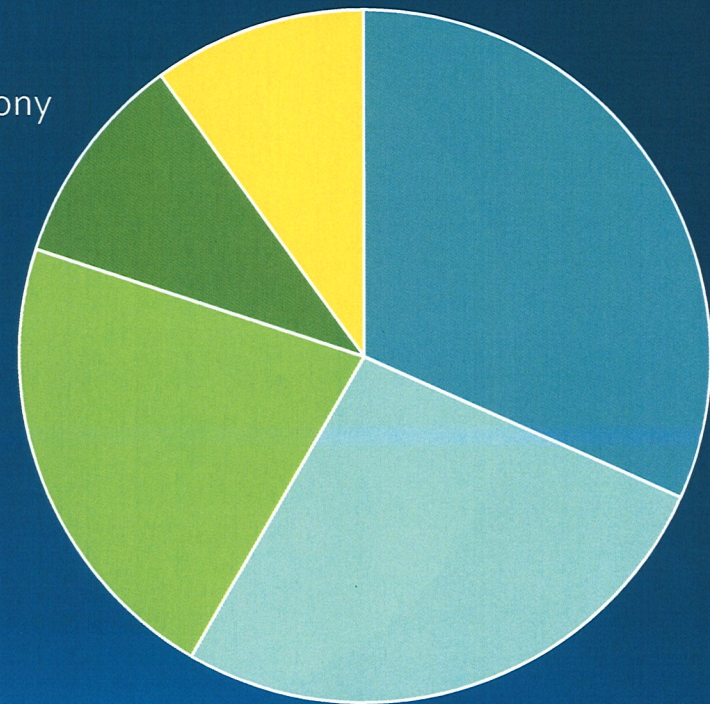

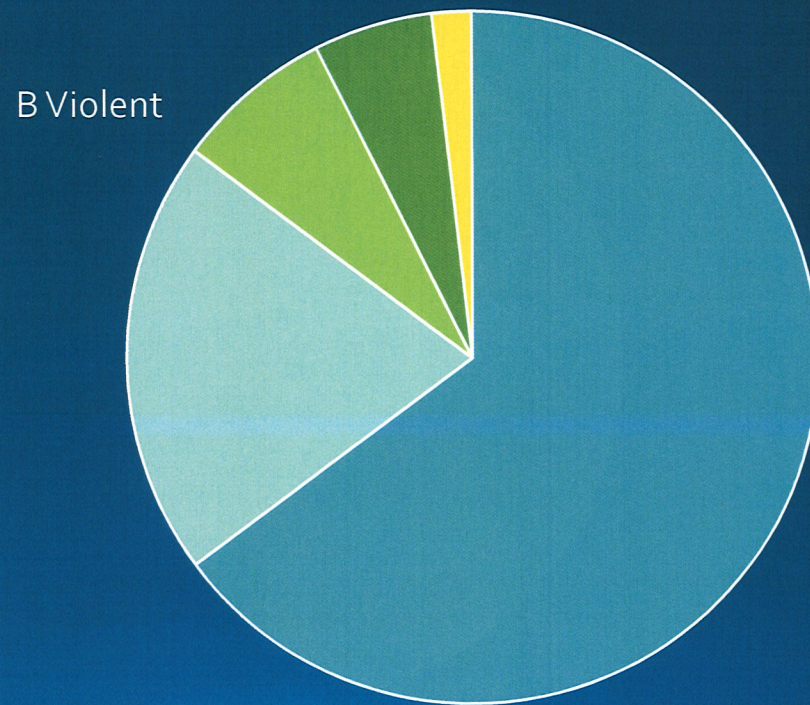

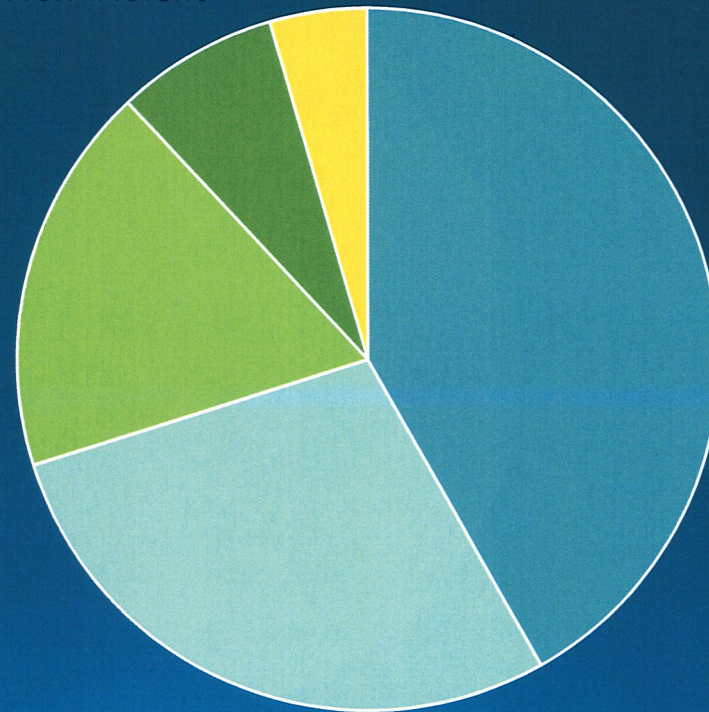

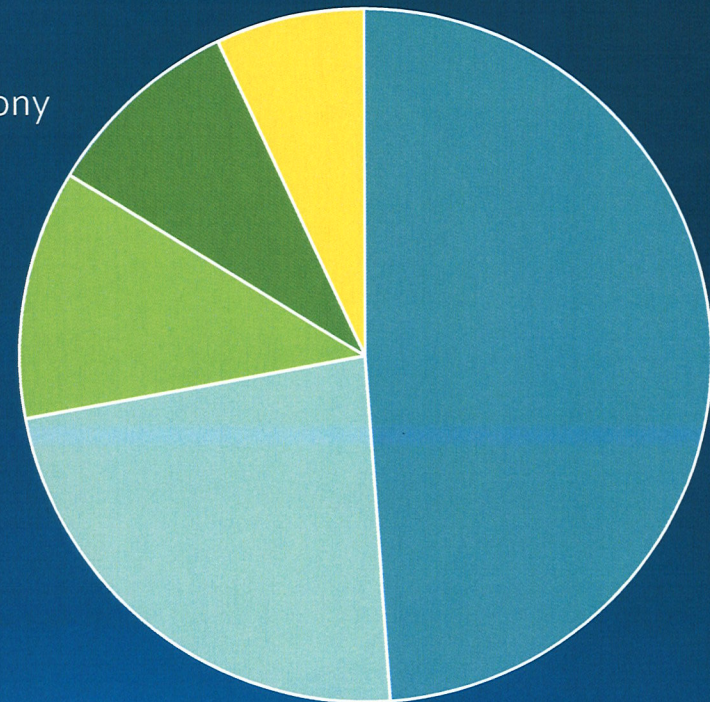

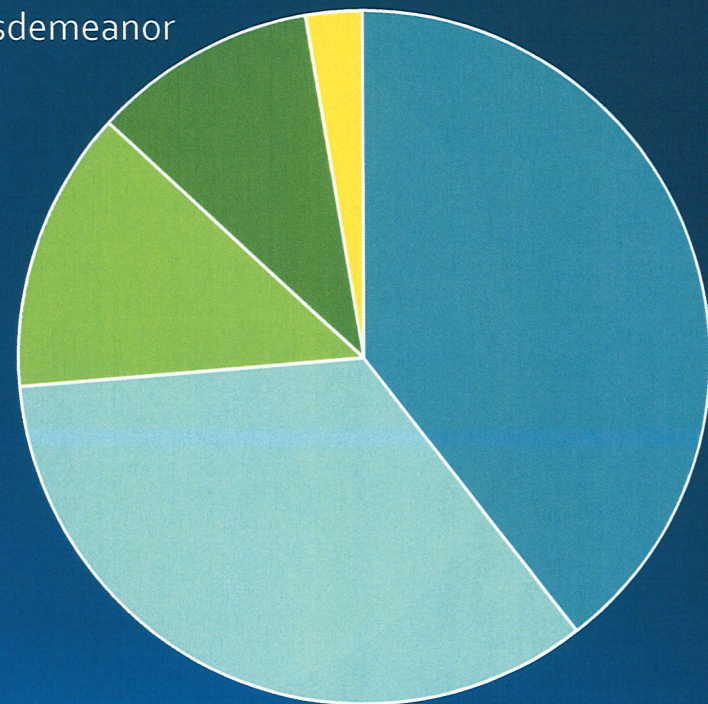
