Greetings WUCC members.

After the April 20 WUCC meeting, the Lummi Nation provided comments on Section 8.1, Tribal Water Issues. We have posted two revised copies of Section 8 to the file sharing site. We have included a version that shows the tracked

changes based on the Lummi's comments. The second version incorporates those changes and is the proposed final version of Section 8. Again, the primary changes are in Section 8.1 which includes sub-sections 8.1.1 - 8.1.3. The only other change was to add the Lummi Peninsula Ground Water Investigation to the list of studies in Section 8.5.2 at the Lummi's request.

We and DOH believe these changes are relatively minor (e.g., corrections to some dates and terminology regarding tribal water issues) and do not warrant an additional meeting of the WUCC. However, if you think another meeting is required to discuss these changes, please contact Gary Stoyka at Whatcom County Public Works.

Gary, Mark Personius, and I are scheduled to brief the Whatcom County Council on the CWSP at 10:00 a.m. on Tuesday, May 24, in the Garden Room at the Civic Center. We anticipate that the Council will schedule a public hearing on the CWSP to be conducted at their regularly scheduled June 14 meeting. WUCC members and other interested parties are welcome at both events to express their views about the CWSP update.

I have also posted the meeting summary from the April 20 WUCC meeting to the file sharing site.

Purchasing policy

Rud,

Thanks for your work on the purchasing policy. It gets us a long way to providing adequate council oversight while allowing for operational certainties and efficiencies. I have comments on three additions that have been made for you to consider:

3.08.100 A. Adjusting the threshold to \$40,000 aligning with the Public Works award amount. I am fine with it.

3.08.100 B. Adding language pertaining to informational material. I know what you are trying to accomplish, but I believe it is out of place in a purchasing policy. If council wants oversight on something that the money has been appropriated on, put specific restrictions in the sideboards of the appropriation. This is not a deal breaker, but it is an odd policy for this section of code that infringes on executive authority to carry out the tasks assigned to it.

3.08.135 Sunset provision – Council has authority to change (any) purchase policy whenever it chooses to, therefore I ask that this provision be removed. Question; Do contracts signed before December 31, 2017 follow this new policy beyond December 31, 2017, or do they revert back to the old one? This provision will create more challenges that it will solve.

Again, thanks for your work on this.

Ordinance 2016-032. Section 3.08.060 reads, in part (brackets my addition): "Awards of contracts for the acquisition of materials, supplies, services, tools, equipment or rental of personal property and professional services [...] \$40,000 will be based upon bids or proposals received in response to specifications and invitations to bid, except as follows:"

We have added the word "exceeding" in the bracketed area, since that seemed to be the intent of the section. Let me know if this should be handled differently.

Could you please let me know what you intend for this ordinance and I will pass that along to Code Publishing. Also, If there is a change in the wording and you'd like to give me a new copy of that page to substitute in the ordinance I can do that. Just let me know. =)
