The Whatcom County Council will hold a public hearing, consider adopting, and may amend the following at its 6 p.m. meeting on July 25, 2023, or at a later date: **ORDINANCE ADOPTING AMENDMENTS TO WHATCOM COUNTY CODE CH. 20.14, WIND ENERGY SYSTEMS, AND CH. 20.97, DEFINITIONS (AB2023-397)**: This ordinance amends Whatcom County Code 20.14, Wind Energy Systems, and Whatcom County Code 20.97, Definition, to make County code more consistent with federal regulations and industry best practices. This ordinance was introduced on June 20, 2023.

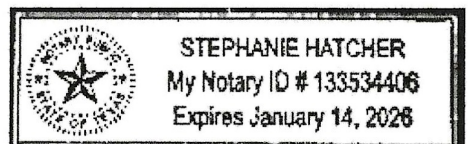
