The Whatcom County Council adopted the following at its November 19, 2024, meeting: ORDINANCE (2024-049) AUTHORIZING THE SEVEN-YEAR CAPITAL IMPROVEMENT PROGRAM FOR WHATCOM COUNTY FACILITIES 2025-2031 (AB2024-697); This ordinance adopts the Seven-Year Capital Improvement Program (CIP) for Whatcom County Facilities 2025-2031 (Appendix F of the Whatcom County Comprehensive Plan). The CIP addresses parks, trails, and active centers, maintenance and operations, general government buildings and sites, Sheriff's Office facilities, emergency management, adult corrections, juvenile detention, transportation (including the ferry), and stormwater projects. This ordinance repeals the existing Six-Year Capital Improvement Program for Whatcom County Facilities 2023-2029. This ordinance was introduced on November 6, 2024. ORDINANCE (2024-050) AUTHORIZING THE LEVY OF TAXES FOR COUNTYWIDE EMERGENCY MEDICAL PURPOSES FOR 2025 (AB2024-726); This ordinance authorizes the 2025 levy of taxes for Countywide Emergency Medical Purposes for an increased amount of \$133,940. This ordinance was introduced on November 6, 2024. ORDINANCE (2024-051) AUTHORIZING THE LEVY OF TAXES FOR CONSERVATION FUTURES PURPOSES FOR 2025 (AB2024-725); This ordinance authorizes the 2025 levy of taxes for Conservation Futures Purposes for an increased amount of \$133,940. This ordinance was introduced on November 6, 2024. ORDINANCE (2024-052) AUTHORIZING THE LEVY OF TAXES FOR COUNTY ROAD PURPOSES FOR 2025 (AB2024-730); Pursuant to Home Rule Charter Section 6.10, this ordinance authorizes the levy of taxes for County Road purposes in 2025. This ordinance was introduced on November 6, 2024. ORDINANCE (2024-053) AUTHORIZING THE LEVY OF TAXES FOR COUNTY AND STATE PURPOSES IN WHATCOM COUNTY, WASHINGTON FOR THE YEAR OF 2025 (AB2024-731); This ordinance adopts the Whatcom County Charter Section 6.10. This ordinance was introduced on November 6, 2024. RESOLUTION (2024-049) AMENDING THE LEVY OF TAXES FOR THE WHATCOM COUNTY FLOOD CONTROL ZONE DISTRICT FOR 2025 (COUNCIL, ACTING AS THE FLOOD CONTROL ZONE DISTRICT BOARD OF SUPERVISORS) (AB2024-732); In accordance with RCW 86.15.160(3), this resolution amends the Whatcom County Flood Control Zone District Board of Supervisors authorizes the levy of taxes with the district for 2025. This resolution was introduced on November 6, 2024. RESOLUTION (2024-050) ADOPTING THE 2025 BUDGET FOR THE WHATCOM COUNTY FLOOD CONTROL ZONE DISTRICT AND SUBZONES (COUNCIL, ACTING AS THE FLOOD CONTROL ZONE DISTRICT BOARD OF SUPERVISORS) (AB2024-742); This resolution adopts a 2025 budget for the countywide district and the following subzones: Arroyo Zaiter Subzone, Lynden-Emerson Subzone, Samish-Nooksack Subzone, Skagit Bay Watershed and Aquatic Resources Management District. This resolution was introduced on November 6, 2024. ORDINANCE (2024-053) AUTHORIZING THE 2025 WHATCOM COUNTY UNIFIED FEE SCHEDULE (AB2024-743); This ordinance authorizes a centralized listing of fees charged by Whatcom County, a complete listing of which can be viewed online via the Council's Legislative Information Center at Whatcom.gov. A copy can also be requested by calling the Council Office at 311 Grand Ave., Suite 105, Bellingham, WA. This ordinance was introduced on November 6, 2024. ORDINANCE (2024-057) IN THE MATTER OF THE ADOPTION OF THE FINAL BUDGET OF WHATCOM COUNTY FOR THE BIENNIAL 2025-2026 (AB2024-748); This ordinance adopts the Whatcom County 2025-2026 budget, places modifications on certain portions, authorizes actions, and authorizes a complete listing of all matters by department can be viewed at Whatcom.gov. This ordinance was introduced on November 6, 2024. ORDINANCE (2024-054) AMENDING THE PROJECT BUDGET FOR THE CENTRAL SHOP NPDES STORMWATER IMPROVEMENTS PROJECT FUND, REQUEST NO. 1 (AB2024-719); This ordinance amends Ordinance No. 2023-048 to add \$2,014,000 of expenditure authority to the project budget for the Central Shop NPDES Stormwater Improvements Project Fund for a revised total budget of \$2,369,500. This ordinance was introduced on November 6, 2024. ORDINANCE (2024-055) AMENDING THE PROJECT BUDGET FOR THE COXHEM ROAD/ANDERSON CREEK BRIDGE NO. 246 REPLACEMENT FUND AND PROJECT BASED BUDGET, REQUEST NO. 1, IN THE AMOUNT OF \$200,000, FOR A TOTAL AMENDED AMOUNT OF \$700,000 (AB2024-743); This ordinance amends Ordinance No. 2021-079 to add \$200,000 of expenditure authority to the project based budget for the Coxhem Road/Anderson Creek Bridge No. 246 Replacement Fund for a new total of \$700,000. This ordinance was introduced on November 6, 2024. ORDINANCE (2024-058) AMENDING THE 2024 WHATCOM COUNTY BUDGET, REQUEST NO. 14, IN THE AMOUNT OF \$4,564,923 (AB2024-744); This ordinance amends the 2024 Whatcom County Budget as follows: From the General Fund, appropriate \$1,600,000 in Health to fund continuation of special settlement dollars to the 23-Hour Oriel Relief Center; appropriate \$489,800 in supplemental \$489,800 appropriate \$7,500 in Sheriff to fund purchase of E-Bikes from Whatcom Community Foundation donation. From the Road Fund, appropriate \$13,950 in Public Works to fund road contribution for new Lurmi Island Terminal spring lines completion supplemental \$4903 and longer gangway for ADA compliance companion to supplemental \$4804 ferry expenses; appropriate \$2,014,000 in Public Works to fund contribution for the Central Shop NPDES Stormwater project budget amendment no. 1 companion to supplemental \$4808. From the Elections Fund, appropriate \$40,000 to fund O&M information security grant from the Washington Secretary of State. From the Jail Fund, appropriate \$150,000 in Corrections to fund H&A Medicaid Reentry Project with grant proceeds; appropriate \$6,473 in Corrections to fund Header Measure Work with grant proceeds. From the Public Utilities Fund, appropriate \$700,000 to fund Habitat for Humanity land acquisition. From the Ferry Fund, appropriate \$16,000 in Public Works to fund new Lurmi Island Terminal spring lines; appropriate \$15,000 in Public Works to fund longer gangway during dry docks for ADA compliance. This ordinance was introduced on November 6, 2024. ORDINANCE (2024-057) AMENDING THE PROJECT BUDGET FOR THE 23-HOUR CRISIS RELIEF CENTER PROJECT FUND, REQUEST NO. 1, IN THE AMOUNT OF \$1,000,000 TO FUND DESIGN AND CONSTRUCTION PHASES OF THE PROJECT FOR A TOTAL PROJECT BUDGET OF \$2,000,000. This ordinance was introduced on November 6, 2024. ORDINANCE (2024-058) AMENDING THE PROJECT BUDGET FOR THE HOWARD PARK BUILDING IMPROVEMENT PROJECT, REQUEST NO. 3 (AB2024-749); This ordinance amends Ordinance No. 2021-088 to fund design and construct replacing roof top mechanical units and phase for a total project budget of \$1,044,807. This ordinance was introduced on November 6, 2024. ORDINANCE (2024-057) AMENDING THE PROJECT BUDGET FOR THE INTEGRATED LAND RECORDS AND PERMIT MANAGEMENT SYSTEM FUND, REQUEST NO. 3 (AB2024-752); This ordinance appropriates \$250,000 to fund phase II of the permit system project for a total project budget of \$3,206,661. This ordinance was introduced on November 6, 2024.

The Whatcom County Council will hold a public hearing, consider adopting, and may amend the following at its 6 p.m. meeting on December 3, 2024, or at a later date: ORDINANCE ADOPTING AMENDMENTS TO WHATCOM COUNTY CODE TITLES 20 AND 22 TO ENACT SB 5290 REGARDING LOCAL PROJECT REVIEW (AB2024-793); This ordinance adopts amendments to Whatcom County Code Titles 20 and 22 to enact SB 5290 regarding local project review. This ordinance was introduced on November 19, 2024. ORDINANCE AMENDING WHATCOM COUNTY CODE TITLE 20 (ZONING) TO DEFINE APPROPRIATE INDUSTRIAL USES AND CONDITIONS FOR INDUSTRIAL USES IN HEAVY IMPACT INDUSTRIAL, HIGH DISTRICTS WITHIN A CITY'S DESIGNATED URBAN GROWTH AREA (AB2024-796); This ordinance amends Whatcom County Code Title 20, zoning, to define appropriate industrial uses and conditions for industrial uses in Heavy Impact Industrial Districts within a city's designated Urban Growth Area. This ordinance was introduced on November 19, 2024. RESOLUTION ADOPTING THE 2025-2026 BUDGET FOR THE POINT ROBERTS TRANSPORTATION BENEFIT DISTRICT (COUNCIL, ACTING AS THE GOVERNING BODY OF THE POINT ROBERTS TRANSPORTATION BENEFIT DISTRICT) (AB2024-802); This resolution adopts the 2025-2026 biennial budget for the Point Roberts Transportation Benefit District with a budget of \$2,000,000 per year. This resolution was introduced on November 19, 2024.

The Whatcom County Council will consider adopting and may amend the following at its 6 p.m. meeting on December 3, 2024, or at a later date: ORDINANCE ESTABLISHING A PROJECT BASED BUDGET FOR THE CENTRAL SHOP UNDERGROUND STORAGE TANK REMOVAL PROJECT (AB2024-760); This ordinance establishes, effective retroactively, a Central Shop Underground Storage Tank Removal Project Fund with an initial budget of \$2,241,000. This ordinance was introduced on November 19, 2024. ORDINANCE AMENDING THE PROJECT BASED BUDGET FOR THE NORTH FORK ROAD/KENNEY CREEK FISH PASSAGE PROJECT FUND, REQUEST NO. 1 (AB2024-768); This ordinance amends Ordinance No. 2021-080, which established a project based budget for the North Fork Road/Kenney Creek Fish Passage Fund, adding \$2,075,000 of expenditure authority to the project budget for a new total of \$3,500,000. This ordinance was introduced on November 19, 2024. RESOLUTION AMENDING THE 2024 FLOOD CONTROL ZONE DISTRICT AND SUBZONES BUDGET, REQUEST NO. 7, IN THE AMOUNT OF \$20,695 (COUNCIL, ACTING AS THE WHATCOM COUNTY FLOOD CONTROL ZONE DISTRICT BOARD OF SUPERVISORS) (AB2024-770); This ordinance appropriates \$10,697 from River & Flood and \$5,351 from Natural Resources to Overhead Administration to contribute as share in reconnection costs for the Central Shop Underground Storage Tank Project Fund. This ordinance also appropriates \$4,267 from River & Flood and Overhead Administration to cover its portion of the increased utility costs through the remainder of 2024, for a net balance of \$2,052. This ordinance was introduced on November 19, 2024. ORDINANCE AMENDING THE 2024 WHATCOM COUNTY BUDGET, REQUEST NO. 15, IN THE AMOUNT OF \$1,645,105 (AB2024-775); This ordinance amends the 2024 Whatcom County budget as follows: From the General Fund, appropriate \$44,000 in District Court to fund related costs; appropriate \$25,000 in Superior Court to fund installation of AVS system for Water adjudication; appropriate \$93,200 in Superior Court to fund pretrial services expenditures funded by Administrative Office of the Courts grant; appropriate \$25,000 in Superior Court Clerk to fund initiation in registration, training, membership dues, and overtime; appropriate \$100,000 in Superior Court Clerk to fund court/court professional services costs; record a revenue appropriation of \$7,500,000 in Sheriff to accept American Rescue Plan Act revenue less transfer to facilitate spending on general government services companion to supplemental \$4825; appropriate \$7,500,000 in Non-Departmental to fund transfer of General Fund savings to the Community Protection Fund companion to supplemental \$4825; appropriate \$17,278 in Non-Departmental to fund transfer for the Central Shop Underground Storage Tank Removal project companion to supplemental \$4814; appropriate \$78,000 in Non-Departmental to fund transfer for security screening services companion to supplemental \$4822; appropriate \$108,546 in Non-Departmental to fund increased utilities costs companion to supplemental \$4821. From the Road Fund, appropriate \$2,373,819 in Public Works to fund transfers for the Central Shop Underground Storage Tank Removal project budget and the North Fork Road/Kenney Creek Fish Passage project budget companion to supplemental \$4814 and \$4815; appropriate \$1,669 in Public Works to fund increased utilities costs companion to supplemental \$4821. From the Elections Fund, appropriate \$2,617 to fund increased utilities; appropriate \$4,609 to fund increased utilities costs companion to supplemental \$4821. From the Stormwater Fund, appropriate \$692 to fund transfers for the Central Shop Underground Storage Tank Removal project budget and the North Fork Road/Kenney Creek Fish Passage project budget companion to supplemental \$4821. From the Behavioral Health Fund, appropriate \$2,200 to fund increased utilities costs companion to supplemental \$4821. From the Community Protection Fund, record a revenue appropriation of \$7,500,000 to accept transfer of General Fund savings as a result of American Rescue Plan spending on general government services. From the Real Estate Excise Tax Fund, appropriate \$1,228,000 in Non-Departmental to fund transfer for the Central Shop Underground Storage Tank Removal project budget companion to supplemental \$4814. From the Equipment, Rental, and Revolving Fund, appropriate \$10,055 in Public Works to fund transfer of the Central Shop Underground Storage Tank Removal project budget companion to supplemental \$4814; appropriate \$4,127 in Public Works to fund increased utilities costs companion to supplemental \$4821. From the Administrative Services Fund, appropriate \$195,000 in Facilities to fund increased utility costs due to inflation; appropriate \$70,000 in Facilities to fund increased security screening services in the courthouse. This ordinance was introduced on November 19, 2024. ORDINANCE AMENDING ORDINANCE 2013-022 TO ALLOW THE ROAD FUND TO ISSUE CASH-FLOW LOANS TO CAPITAL PROJECT BUDGETS IN THE AMOUNT OF \$1 MILLION TO \$2 MILLION FOR A TERM NOT TO EXCEED TWO YEARS (AB2024-776); This ordinance authorizes the Whatcom County Treasurer to make interest-free, interest-free, interest-free, not to exceed \$2,000,000 per project and not for a term exceeding two years, from the Road Fund to Capital Projects Funds for cash flow purposes. This ordinance was introduced on November 19, 2024. ORDINANCE AMENDING THE 2025 WHATCOM COUNTY BUDGET, REQUEST NO. 1, IN THE AMOUNT OF \$16,200,701 (AB2024-780); This ordinance amends the 2025 Whatcom County Budget to appropriate \$16,292,701 to fund the Annual Construction Program. This ordinance was introduced on November 19, 2024. ORDINANCE ESTABLISHING WHATCOM COUNTY CODE 3.100 BIRCH BAY COMMUNITY ADVISORY COMMITTEE (AB2024-794); This ordinance establishes Whatcom County Code 2.190, Birch Bay Community Advisory Committee. This ordinance was introduced on November 19, 2024. ORDINANCE AMENDING WHATCOM COUNTY CODE 2.03, ADVISORY GROUPS (AB2024-795); This ordinance amends Whatcom County Code 2.03, Advisory Groups, to improve operating efficiencies for advisory groups and management by County staff and Council. This ordinance was introduced on November 19, 2024.

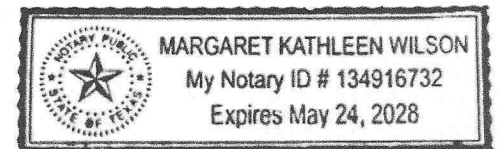
