COUNCIL ACTION TAKEN

The Whatcom County Council adopted the following at its March 26, 2019, meeting:

ORDINANCE (2019-024) AMENDING WHATCOM COUNTY CODE CHAPTER 6.04, ANIMAL CONTROL (AB2019-153):

This ordinance amends Whatcom County Code (WCC) 6.04 to provide regulations within the unincorporated areas of Whatcom County and specific controls within designated urban areas of Whatcom County to control animal conduct. The purpose of the amendments is to more clearly identify the entities (including a humane society) that may be authorized and obligated to administer and enforce provisions of the WCC related to animal control; to update the definitions to include humane societies, and other animal care/control agencies as animal control authorities; and to define the animal control officer for purposes of the WCC.

ORDINANCE (2019-025) INCREASING SHERIFF'S OFFICE PETTY CASH FUND (AB2019-150):

This ordinance authorizes the increase in the Sheriff's Office petty cash fund to a total of \$300 for three separate cash drawers in order to provide change when receipting payments from customers.

AB2019-150

ORDINANCE (2019-026) AMENDING THE 2019 BUDGET, REQUEST NO. 4 (AB2019-160):

This ordinance adds appropriations to the Health Fund (\$114,985), Sheriff (\$14,740), Road Fund (\$450,000), Behavioral Health Program Fund (\$249,927), Solid Waste Fund (\$560,000), and Convention Center (Lodging Tax) Fund (\$35,000), in a total supplemental amount of \$1,424,652.

ORDINANCE (2019-027) REPEALING ORDINANCE 2019-017

WHATCOM COUNTY CODE SECTION 6.05, ANIMAL CONTROL (AB2019-156):

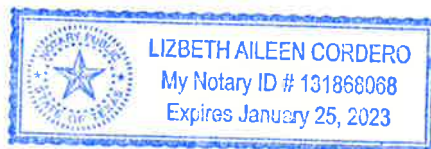
