RE: Clean Earth Environmental Solutions, Inc. (Clean Earth) – Disposal of Toxics Facility, Disposal and Transport Services Contract Amendment #1

DATE: JUNE 11, 2026

Attached is a contract amendment between Whatcom County and Clean Earth for your review and signature. An initial one-year contract for these services was executed to facilitate continuity of operations during the transition of the County's oversight of the Disposal of Toxics Facility. This amendment authorizes a three-year extension in order to ensure the uninterrupted period of services through the conclusion of the contract's permissible extension period. Total and unit pricing in this amendment will represent a 5% increase from those in the initial contract period, reflecting increases in the costs of transportation, storage, and disposal of hazardous waste. This amendment also authorizes the parties to conduct an annual review of costs to evaluate whether adjustments to the pricing are appropriate to account for additional increases in costs.

▪ **Background and Purpose**

This contract provides funding for transportation and disposal of moderate risk waste from Whatcom County's Disposal of Toxics Facility. Whatcom County owns and operates the Facility located at 3505 Airport Drive in Bellingham, which receives household hazardous waste and conditionally exempt small quantity generator hazardous wastes.

▪ **Funding Amount and Source**

Funding for this contract, in an amount not to exceed \$367,500 annually (July through June), is provided by the Department of Ecology's Local Solid Waste Financial Assistance Agreement (\$342,500 annually) and the Solid Waste Fund (\$25,000). Council is concurrently considering a supplemental budget request to augment spending authority for this expenditure. Council authorization is required as the funding proposed by this amendment exceeds 10% of the amount previously authorized by Council.

THE CONTRACT IDENTIFIED HEREIN, INCLUDING ANY PREVIOUS AMENDMENTS THERETO, IS HEREBY AMENDED AS SET FORTH IN THE DESCRIPTION OF THE AMENDMENT BELOW BY MUTUAL CONSENT OF ALL PARTIES HERETO

DESCRIPTION OF AMENDMENT:

1. Pursuant to the original contract "General Terms, Section 40.1, Modifications", amends Section 10.2 of the original contract to authorize a three-year extension, not to exceed a cumulative total of four years, including the original term.
2. Extends the duration and other terms of this contract for three years, pursuant to the original contract "General Terms, Section 10.2, Extension". The cumulative term of this contract may not extend beyond 06/30/2029.
3. Pursuant to the original contract "General Terms, Section 40.1, Modifications", amends Exhibit A – Scope of Work to add Section IV. Annual Pricing Review to authorize annual evaluations of costs.
4. Pursuant to the original contract "General Terms, Section 40.1, Modifications", amends Exhibit B – Compensation to reflect the total annual not-to-exceed amounts.
5. Pursuant to the original contract "General Terms, Section 40.1, Modifications", amends Exhibit C – Pricing Per Unit to reflect a 5% increase in costs.
6. Annual (July through June) funding for this contract may not exceed \$367,500.
7. Funding for the total contract period (07/01/2025 – 06/30/2029) is not to exceed \$1,452,500.
8. All other terms and conditions remain unchanged.
9. The effective start date of the amendment is 07/01/2026.

ALL OTHER TERMS AND CONDITIONS OF THE ORIGINAL CONTRACT AND ANY PREVIOUS AMENDMENTS THERETO REMAIN IN FULL FORCE AND EFFECT. ALL PARTIES IDENTIFIED AS AFFECTED BY THIS AMENDMENT HEREBY ACKNOWLEDGE AND ACCEPT THE TERMS AND CONDITIONS OF THIS AMENDMENT. 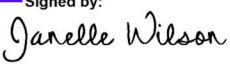
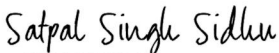

EXHIBIT "A" – Amendment #1
(SCOPE OF WORK)

I. Background and Purpose

This contract provides funding for transportation and disposal of moderate risk waste from Whatcom County's Disposal of Toxics Facility. Whatcom County owns and as of July 1, 2025, operates the Facility, located at 3505 Airport Drive in Bellingham, which receives Household Hazardous Waste and Conditionally Exempt Small Quantity Generator hazardous wastes.

II. Statement of Work

The Contractor will provide transportation and disposal of moderate risk waste (MRW) from Whatcom County's Disposal of Toxics Facility (Facility) and off-site collection events, and temporary labor if and when needed, in the event that the Facility is short-staffed, as outlined below:

- a. The Contractor will provide all management, materials, equipment, labor, and other items necessary to provide pick up, transportation, and final management of MRW collected at the Facility and mobile collection events (including those in Point Roberts, requiring the transit of MRW through Canada) in accordance with all applicable local, state, and federal laws and regulations.
 1. Pick up, transportation, and disposal management services will be provided on an as-needed basis. Pick up of MRW is required no later than seven (7) business days after request of pick up.
 - a. The County prefers universal waste, hazardous, and non-hazardous waste management methods that are based on the following hierarchy:
 - i. Recycling and reuse
 - ii. Energy recovery
 - iii. Treatment conversion to non-hazardous or less hazardous compounds
 - iv. Incineration
 - v. Hazardous waste landfill
- b. The Contractor will develop preapproved waste profiles for standard classes of MRW, so that containers packaged by facility staff can be removed from the facility during each pickup.
- c. The Contractor shall prepare the manifest and load and deliver MRW from the Facility to a permitted hazardous waste Treatment, Storage, and Disposal Facility (TSDF).
- d. The Contractor shall provide accurate and timely service documentation, including copies of manifests, TSDF records, and certificates of final disposal.
 1. Original signed copies of manifests must be received within 45 days of the date the manifest shipped.
 2. Certificates of final disposition must be received within six (6) months of the date the manifest shipped.
- e. The Contractor shall provide reference material and administrative support to assist Whatcom County staff in the classification, sorting, packing, and labeling of collected wastes.
- f. The Contractor shall provide materials and supplies upon request within seven (7) business days.

- g. The Contractor shall provide on-call staffing of trained and experienced MRW workers if the County is short-staffed with its own MRW staff.
- h. The Contractor shall meet regularly with the County and make periodic recommendations and guidance on alternative waste management techniques and options with emphasis placed on reuse and recycling of processed material.

III. Program Requirements

The Contractor will:

- a. Follow best practices to safely manage hazardous waste.
- b. Handle and dispose of hazardous waste in accordance with all applicable laws.
- c. Maintain licenses, permits, certifications, and other regulatory items applicable to this contract, as required under international, federal, state, or local statutes, regulations or standards for transportation and disposal of all materials.
- d. Report any significant citation, violation, administrative order, judgment, or other enforcement action regarding improper operational, safety, or environmental activity. This condition is applicable to any TSDF, subcontractor, and/or other agent utilized under this contract.
- e. Provide copies of manifesting, loading and unloading, training, health and safety, emergency and spill, and other procedures upon request by the County.

IV. Annual Pricing Review

The Parties agree to review the pricing set forth in this contract (Exhibit C) on an annual basis. See Exhibit B – Section III. for additional requirements.

EXHIBIT “B” – Amendment #1
(COMPENSATION)

- I. The source of funding for this contract, in an amount not to exceed \$367,500 annually (07/01/26-06/30/27, 07/01/27-06/30/28, 07/01/28-06/30/29), is provided by the Washington State Department of Ecology's Local Solid Waste Financial Assistance Agreement (\$342,500) and the Solid Waste Fund (\$25,000).
- II. Pricing for this contract will be reimbursed based on the rates indicated in Exhibit C – Pricing Per Unit.
 - a. The Contractor must request approval for reimbursement of rates that are not included in Exhibit C by email, from the County's Contract Administrator.
- III. A request for price escalation as outlined in Section IV of Exhibit A: **1)** must be submitted at least sixty (60) days prior to June 30th of each year; **2)** must be approved by the Parties through written amendment to this contract; and **3)** will only be allowed on a pass-through basis (does not result in a higher profit margin than that reflected in the prices awarded in this original contract).
 - a. The Contractor shall provide documentation satisfactory to the County in support of its request, such as changes to the Producers Price Index for the commodity, the Consider Price Index (CPI), or a manufacturer's published notification of price change(s).
 - i. The Contractor may propose an annual increase that is the greater of the CPI from the previous year or 5%.
 - b. Documentation will include a cost proposal in sufficient detail for the County to perform a cost/price analysis upon which the original proposal was made. An evaluation and/or audit will be performed on the cost proposal as well as other submitted documentation in order to determine if the requested price increase(s) is fair and reasonable.
 - c. The County reserves the right, in its sole discretion, to grant the request as submitted, engage the Contractor in a discussion about modifications to the request, or deny the request in its entirety. Any change in pricing granted by the County shall be affected through a written contract amendment instituting the price adjustment and establishing an effective date.

EXHIBIT "B.1" – Invoicing – General Requirements

1. When applicable, indirect costs and fringe benefit cost rates may not exceed the amount indicated in Exhibit B or the Contractor's federally approved indirect cost rate.
2. The Contractor shall submit invoices indicating the County-assigned contract number to:
HL-BusinessOffice@co.whatcom.wa.us and JHayden@co.whatcom.wa.us
3. The Contractor shall submit itemized invoices on a monthly basis in a format approved by the County and by the 15th of the month, following the month of service, except for January and July where the same is due by the 10th of the month.
4. When applicable, the Contractor will utilize grant funding sources in the order of their expiration date as indicated by the County, prior to spending local funding sources, when no funding restrictions prevent doing so.
5. The contractor shall submit the required invoice documentation identified in Exhibit B.
 - a. The County reserves the right to request additional documentation in order to determine eligible costs. Additional documentation must be received within 10 business days of the County's request.
 - b. When applicable, if GL reports for personnel reimbursement do not specify position titles, additional documentation must be provided that includes staff name and position title.
 - c. When applicable, mileage will be reimbursed at the current GSA rate (www.gsa.gov). Reimbursement requests for mileage must include:
 1. Name of staff member
 2. Date of travel
 3. Starting address (including zip code) and ending address (including zip code)
 4. Number of miles traveled
6. Payment by the County will be considered timely if it is made within 30 days of the receipt and acceptance of billing information from the Contractor.
7. The County may withhold payment of an invoice if the Contractor submits it or the required invoice documentation, more than 30 days after the month of services performed and/or the expiration of this contract.
8. Invoices must include the following statement, with an authorized signature and date: **I certify that the materials have been furnished, the services rendered, or the labor performed as described on this invoice.**
9. Duplication of billed costs or payments for service: The Contractor shall not bill the County for services performed or provided under this contract, and the County shall not pay the Contractor, if the Contractor has been or will be paid by any other source, including grants, for those costs used to perform or provide the services in this contract. The Contractor is responsible for any audit exceptions or disallowed amounts paid as a result of this contract.

B. Waste Specific Conditions

1. Disposal prices for gas cylinders are for those with original label, operable valve and in acceptable DOT shipping condition.
 - a. Unknown identification fee of \$350 may be charged for each unknown gas that is sampled and analyzed
 - b. A confirmation fee of \$200 may be charged for each suspected gas that requires confirmation due to lack of original label. If results do not match suspected contents, then unknown ID rate will apply along with additional disposal costs if applicable.
 - c. Inoperable valve fee: No charge for Category A cylinders. For Categories B thru E, a tapping fee of \$350 per cylinder will apply regardless of size of cylinder. For categories F & G, inoperable valve fee will be Case-by-Case.
2. Batteries not in original manufacturer's packaging must have both ends taped to avoid arc. Additional fees may apply if Clean Earth personnel must tape the battery ends.
