Helping the criminal justice system become more equitable and just is a vital part of ensuring a healthy society, and I am inspired and intrigued by the work the Incarceration Prevention and Reduction Task Force does to forward these goals. I care deeply about helping to enact criminal justice policies that honor the dignity of the human person, and was excited to see an opening on the task force for a concerned citizen. I've been looking for ways to get involved in public service in Whatcom County, and my interest in the Incarceration Prevention and Reduction Task Force in particular was piqued by a piece in a local newspaper about the GRACE program. Since that time I've kept a close eye on innovations in reducing incarceration locally, and to this end began volunteering for a restorative justice non-profit to help people navigate the court system.
