### PUBLIC HEARING NOTICE (Virtual Meeting)

Whatcom County Council will have a public hearing, consider adopting, and may amend the following at its October 13, 2020, 6 PM meeting, or at a later date:

**ORDINANCE REGARDING INSTALLATION OF A STOP SIGN ON HOMESTEADER ROAD (AB2020-390):** This ordinance is to install a stop sign on Homesteader road for westbound traffic on Homesteader road at the intersection with Standard Road. Council introduced the above at its September 29, 2020 meeting.

**ORDINANCE TO ESTABLISH SPEED LIMITS ON MARINE DRIVE (AB2020-391):** This ordinance will modify speed limits on portions of Marine Drive, to reduce the speed limit to 35 mph on Marine Drive from 1000 feet east of Locust Avenue to Old Marine Drive and 30 mph on Marine Drive from Old Marine Drive to Bancroft Road. Council introduced the above at its September 29, 2020 meeting.

**ORDINANCE AMENDING WHATCOM COUNTY CODE 16.30 LAKE WHATCOM STORMWATER UTILITY SERVICE AREA REGARDING CLARIFICATION OF REQUIREMENTS OF CAPITAL FACILITIES CHARGES (AB2020-393):** This amendment modifies the definition of "Equivalent service unit" (ESU) from the original ordinance for clarification when implementing the regulation. Modifies the definition of "Impervious surface" to be consistent with the current adopted definition within Whatcom County Code. Expands on how the CFC is assessed to single-family residential parcels and other developed parcels. Council introduced the above at its September 29, 2020 meeting.

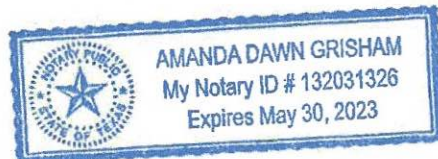
