RESOLUTION NO. 2023 - 038

APPROVING THE WHATCOM COUNTY 2024 ANNUAL CONSTRUCTION PROGRAM

WHEREAS, pursuant to RCW 36.81.130, the Whatcom County Engineer did file with the Whatcom County Council a recommended plan for laying out, construction, maintenance and special maintenance of County roads for the fiscal year of 2024; and,

WHEREAS, the Whatcom County Council held a public hearing on the 24<sup>th</sup> day of October, 2023, and has considered the testimony given as well as the recommended plan; and,

WHEREAS, the Whatcom County Council had determined that said plan is necessary, as nearly as practicable, to the Whatcom County 2024-2029 Six-Year Transportation Improvement Program, approved by Resolution 2023-024 on September 26, 2023.


NOW, THEREFORE, BE IT RESOLVED that the 2024 Whatcom County Annual Construction Program is hereby approved as shown on Exhibit A, attached hereto; and

BE IT FURTHER RESOLVED that no changes be made in the program without the unanimous vote of the Whatcom County Council; and

BE IT FINALLY RESOLVED that upon approval, the 2024 Annual Construction Program be filed with the County Road Administration Board per WAC 136-16-040.
