RE: RESOLUTION ESTABLISHING GUIDELINES FOR COUNCIL APPOINTMENT TO JUDICIAL AND LEGISLATURE VACANCIES

Whatcom County Council has the authority and guidance to make appointments in order to fill judicial and legislative vacancies:

- RCW <u>3.34.100</u>
- Washington State Constitution. <u>Article II</u>, Section 15. Vacancies in Legislature and in Partisan County Elective Office.

In the recent past, the Whatcom County Council has made appointments to fill vacancies in judicial and state legislature positions. The attached examples provide details on the process followed for recent Council appointments. A pattern is evident in the steps taken and can provide a basic framework.

Council staff is providing a proposed resolution establishing the guidelines for appointments to fill a judicial or legislature vacancy in order to clarify the process for future appointments.

- 2) Why are you the best candidate to represent the 40th Legislative District and what distinguishes you from the other nominees?
- 3) If appointed, what will be your top priorities and why?
- 4) Transportation is a key issue for all communities. Share with us your transportation priorities.
- 5) How would you help maintain viable agriculture in the 40th Legislative District?
- 6) Share with us your thoughts on the Growth Management Act, and what, if any changes you would advocate for immediately?
- 7) Housing affordability is a key issue for all communities. Share with us your housing affordability priorities.
- 8) Our communities are also experiencing increasing levels of homelessness. What will you do as a legislator to meet the needs of Washingtonians without a home?
- 9) Local governments face a variety of unfunded mandates initiated by the legislature, as well as the day-to-day costs of facilities and general government operations. What will you do to ensure counties have the funding they need to meet state mandates and provide essential services?
