RE: 2025 Comp Plan Update - Chapter 4 (Capital Facilities)

The Growth Management Act (GMA) requires Whatcom County to review and revise its Comprehensive Plan and development regulations in 2025 (RCW 36.70A.130). The updated Comprehensive Plan will contain the following chapters:

- 1. Introduction and Growth Projections
- 2. Land Use
- 3. Housing
- 4. Capital Facilities
- 5. Utilities
- 6. Transportation
- 7. Economics
- 8. Resource Lands
- 9. Recreation
- 10.Environment
- 11.Shorelines¹
- 12. Climate Change and Resilience (new Chapter)

The Whatcom County Planning Commission issued preliminary recommendations on Chapter 4 on July 24. It is anticipated that the County Council's Committee of the Whole will discuss this Chapter on September 9.

Chapter 4 generally includes:

- Background information, including GMA requirements; and
- Goals and Policies relating to County and special purpose district capital facilities. County capital facilities include law enforcement, corrections,

juvenile detention, emergency management, general government buildings, parks, trails, and activity centers. Special purpose districts include school districts, fire districts, and water & sewer districts.

Proposed changes to Chapter 4 include:

- <u>GMA Provisions</u> Updating text to reflect GMA changes made by the State legislature in recent years relating to climate change and resilience, green infrastructure, and impact fees.
- <u>Activity Centers</u> Updating methods for providing services at activity centers, including senior centers, as recommended by the County Parks Department.
- Special District Plans Chapter 4 adopts various school district, fire district, and water & sewer district plans by reference. Some of these special district plans have been updated since the last County Comprehensive Plan was adopted in 2016. Therefore, the most recent special district plans have been referenced in the Chapter 4 amendments. It is anticipated that other special district plans will be updated in 2025. The references to these plans will be updated in Chapter 4 as they are approved by the respective districts.
- <u>Mitigation Fees/Impact Fees</u> The Planning Commission added text to Goal 4K relating to the effect of school and fire district fees on home affordability.
- <u>Climate Goal and Policies</u> Chapter 4 include new goal 4M and related policies to address greenhouse gas emission reduction and climate resilience for County facilities. The Planning Commission made two changes to these policies.
