RESOLUTION TO DECLARE WHATCOM COUNTY REAL PROPERTY AS SURPLUS AND APPROVE TRANSFER (AB2024-348): This resolution declares as surplus and approves the transfer of tax parcel number 390109 183088 0000, a 6.96-acre tract at 3970 Kickerville Lane, subject to conservation easement, to the Lummi Nation for no consideration, per recommendation by the Whatcom County Property Management Committee and pursuant to RCW 36.34.130 and Whatcom County Code 1.10.340. This resolution was introduced on June 4, 2024.

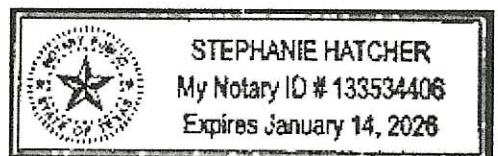
