## Rud Browne – Biography

Rud is the CEO of Ryanna Capital which is currently focused on increasing the buildable lands supply within Whatcom County, a critical first step in adding more housing within a community desperate for additional residential options.

Rud is a proven entrepreneur. He started recycling scrap metal when he was 10 years old. At 23 he taught himself computer programming and then spent 30 years in the hitech sector. At 30 Rud started The Ryzex Group and built it into an innovative multinational mobile technology solutions company with \$75 million in annual revenues, which employed 360 people in five countries. He moved to Whatcom County in 1994.

Rud promoted the recycling ethic to the point that the Ryzex' Bellingham facility (with 160 personnel) was able to eliminate all waste. The lessons learned became the basis of the popular local program called Towards Zero Waste, which has resulted in over 300 organizations reducing their waste by at least 50%.

In 2013 Rud was elected to the Whatcom County Council where he served two terms. During his tenure he served as Council Chair, Chair of the Finance and Administrative Services Committee, as a member of the Planning and Development Committee, the Public Works Committee, the County Health Board and as the Council representative on several other external boards and commissions.

Rud is currently a member of the World Presidents Organization (a global organization of CEO's), the Rotary Club of Bellingham, and the Bellingham Angels Group. In 2004 Rud was recognized as the Whatcom County Businessperson of the Year and in 2007 as a winner of the Ernst & Young Entrepreneur of the Year Award. Under Rud's leadership, Ryzex received numerous awards, including "Best Places to Work," the "Green Business of the Year" and was recognized by Inc.
