COUNCIL ACTION TAKEN

The Whatcom County Council adopted the following at its July 21, 2020 meeting:

ORDINANCE (2020-039) AMENDING THE 2019-2020 BUDGET REQUEST NO. 14. (AB2020-276): This ordinance amended the Budget in the amount of \$1,810,500. Included therein: Homeless Housing Fund \$120,000; Conservation Futures Fund \$995,500; Real Estate Excise Tax II Fund \$695,000. This ordinance was introduced on July 7, 2020.

ORDINANCE (2020-040) ESTABLISHING THE SILVER BEACH CREEK FUND AND ESTABLISHING A PROJECT BASED BUDGET FOR THE SILVER BEACH CREEK STORMWATER IMPROVEMENT FUND (AB2020-277): This ordinance established a new fund titled Silver Beach Creek Stormwater Improvements Fund Phase 1 of the project will treat runoff from approximately 24 acres, with system upgrades which will remove approximately 15 pounds of phosphorus. This ordinance was introduced on July 7, 2020.

RESOLUTION (2020-029) AUTHORIZING THE COUNTY EXECUTIVE TO ENTER INTO A TWENTY-YEAR COMMUNICATION TOWER LEASE AGREEMENT WITH PI TOWER DEVELOPMENT LLC (AB2020-254): This Resolution authorizes the County Executive to enter into a twenty-year lease with Pi Tower Development LLC for tower lease sites located on Lookout Mountain and are remote and do not impede or impact public recreation. Council introduced above at its July 7, 2020 meeting.

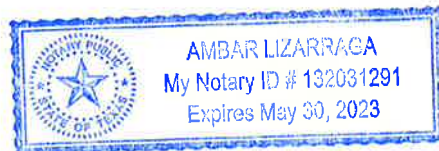
