ACTION TAKEN

The Whatcom County Council adopted the following at its April 12, 2022 meeting: ORDINANCE (2022-028) AMENDING WHATCOM COUNTY CODE SECTION 1.14, ELECTORAL PRECINCTS, ADJUSTING BOUNDARY LINES BASED ON DECENNIAL CENSUS INFORMATION IN THE LEGISLATIVE, CONGRESSIONAL AND COUNTY COUNCIL DISTRICTS (AB2022-177) This ordinance replaces Whatcom County Code Section 1.14 with newly established voting precinct boundaries and substitutes the same into the "Book of Election Precinct Maps" available through the Whatcom County Council Office, the Whatcom Auditor's Office, and online. Ordinance introduced March 22, 2022. ORDINANCE (2022-029) ESTABLISHING MOVEMENT RESTRICTIONS ON E. HEMMI ROAD AT THE INTERSECTION WITH HANNEGAN ROAD (AB2022-162) This ordinance establishes movement restrictions on Hemmi Road at the intersection with Hannegan Road as follows: 1) Left Turns shall be prohibited from westbound E. Hemmi Road to southbound Hannegan Road from 8:30 am to 10:30 am and 3:00 pm to 4:30 pm, during the school year, located in Sections 16, 17, 20 and 21, Township 39 North, Range 3 East, W.M. 2) Through Movements shall be prohibited from westbound E. Hemmi Road to westbound E. Hemmi Road at the intersection with Hannegan Road from 8:30 am to 10:30 am and 3:00 pm to 4:30 pm, during the school year, located in Sections 16, 17, 20 and 21, Township 39 North, Range 3 East, W.M. Ordinance introduced March 22, 2022. ORDINANCE (2022-030) REMOVING A SCHOOL SPEED ZONE ON HANNEGAN ROAD (AB2022-163) This ordinance removes the school speed zone on Hannegan Road from 500 feet north of Ten Mile Road to E. Hemmi 33 Road in Sections 16 and 17, Township 39 North, Range 3 East, W.M. Ordinance introduced March 22, 2022. ORDINANCE (2022-031) ESTABLISHING PARKING CONTROL ON EDDIE LANE WITHIN THE PLAT OF WHISPER LAKE (AB2022-164) This ordinance establishes a No Parking Anytime zone on the north side of Eddie Lane from SR-548/Blaine Road westerly to the cul-de-sac, located within Section 31, Township 40 North, Range 1 East, W.M. Ordinance introduced March 22, 2022. ORDINANCE (2022-032) ESTABLISHING A SPEED LIMIT WITHIN THE PLAT OF WHISPER LAKE (AB2022-165) This ordinance establishes a 25 mile per hour speed limit on all roads within the plat of Whisper Lake, located in Section 31, Township 40 North, Range 1 East, W.M. Ordinance introduced March 22, 2022. ORDINANCE (2022-033) FOR INSTALLATION OF A STOP SIGN WITHIN THE PLAT OF WHISPER LAKE (AB2022-166) This ordinance establishes a new stop sign on Eastbound Eddie Lane at the intersection of SR-548/Blaine Road within Section 31, Township 40 North, Range 1 East, W.M. Ordinance introduced March 22, 2022. ORDINANCE (2022-034) AMENDING WHATCOM COUNTY CODE 2.21, BOARD OF EQUALIZATION (AB2022-190) This ordinance will amend Whatcom County Code 2.21, Board of Equalization, to add two alternate members to the board. Ordinance introduced March 22, 2022.

Ordinance introduced April 12, 2022. ORDINANCE ADOPTING AMENDMENTS TO THE WHATCOM COUNTY COMPREHENSIVE PLAN RELATING TO CAPITAL FACILITIES PLANNING (AB2022-214) This ordinance amends the Six-Year Capital Improvement Program (CIP) for Whatcom County Facilities 2021-2026 (Appendix F of the Whatcom County Comprehensive Plan) by adding the following two projects to the Parks, Trails, and Activity Centers Chapter: (a) Howander Park Tennis Lake Flood Repair and Mitigation Improvements, and (b) Lookout Mountain Road & Culver's Repair and Mitigation Improvements. Ordinance introduced April 12, 2022. ORDINANCE AMENDING WHATCOM COUNTY CODE SECTION 16.50.090 TO INCORPORATE CHANGES TO THE C-PACER PROGRAM ADOPTED BY THE STATE LEGISLATURE IN RCW 36.165.060. (AB2022-221) This ordinance amends Whatcom County Code Section 16.50.090 (Collection and Enforcement) to incorporate changes to the Commercial Property Assessed Clean Energy and Resiliency (C-PACER) Program adopted by the state legislature in RCW 36.165.060. Ordinance introduced April 12, 2022.

The Whatcom County Council will consider adopting and may amend the following at its 6 p.m. meeting on April 26, 2022, or at a later date: RESOLUTION AUTHORIZING THE COUNTY EXECUTIVE TO SIGN THE BLACK SLOUGH COMPREHENSIVE BARRIER REMOVAL DESIGN PROJECT GRANT APPLICATION TO THE BRIAN ABBOTT FISH BARRIER REMOVAL BOARD (COUNCIL ACTING AS THE WHATCOM COUNTY FLOOD CONTROL ZONE DISTRICT BOARD OF SUPERVISORS) (AB2022-193) This resolution authorizes the County Executive, acting on behalf of the Whatcom County Flood Control Zone District, to submit a grant application to the Brian Abbott Fish Barrier Removal Board (BAFBRB). Resolution introduced April 12, 2022. ORDINANCE AMENDING THE PROJECT BUDGET FOR THE SWIFT CREEK CAPITAL PROJECTS FUND, REQUEST NO. 1 (AB2022-215) This ordinance appropriates \$2,041,000 to fund continued design of project elements and the first phase of significant capital construction for a total project budget of \$7,258,159. Ordinance introduced April 12, 2022. RESOLUTION AMENDING THE FLOOD CONTROL ZONE DISTRICT A, SUBZONES, 2022 BUDGET, REQUEST NO. 2, IN THE AMOUNT OF \$110,000 (COUNCIL ACTING AS THE WHATCOM COUNTY FLOOD CONTROL ZONE DISTRICT BOARD OF DIRECTORS) (AB2022-217) This resolution amends the Flood Control Zone District & Subzones 2022 budget as follows: From the Flood Control Zone District Fund, appropriate \$110,000 in Natural Resources to fund a Climate Vulnerability Assessment from grant and transfer proceeds. Resolution introduced April 12, 2022. ORDINANCE AMENDING THE PROJECT BUDGET FOR THE WAY STATION PROJECT FUND, REQUEST NO. 1 (AB2022-219) This ordinance appropriates an additional \$5,708,388 to fund the Way Station project for a total budget of \$8,092,710. Ordinance introduced April 12, 2022. ORDINANCE AMENDING WCC 2.123.040 MEMBERSHIP - TERM OF OFFICE FOR THE FORESTRY ADVISORY COMMITTEE (AB2022-224) This ordinance will amend Whatcom County Code (WCC) 2.123.040 to allow the County Council to waive the registered voter/residency requirement for representatives of commercial forestry landowners on the Forestry Advisory Committee. Ordinance introduced April 12, 2022. ORDINANCE AMENDING THE 2022 WHATCOM COUNTY BUDGET, REQUEST NO. 7, IN THE AMOUNT OF \$6,246,353 (AB2022-225) This ordinance amends the 2022 Whatcom County Budget as follows: From the General Fund: appropriate \$10,000 in Non Departmental to fund support for the Climate Vulnerability Assessment; appropriate \$79,000 in Public Defender to fund increased service costs related to COVID and Bleke cases from grant proceeds; appropriate \$100,000 in Parks to fund Lookout Mountain repairs from FEMA grant proceeds and Real Estate Excise Tax II Fund transfer; re-appropriate \$123,536 in Sheriff to fund Operation Stonegarden FFY19 program from grant proceeds; appropriate \$9,292 in Sheriff to fund stop stick acquisition; appropriate \$3,000 in Sheriff to fund refrigeration unit acquisition from grant proceeds. From the Whatcom County Jail Fund appropriate \$153,350 to fund Northwest Regional Council nursing service wage increase. From the Homeless Housing Fund: appropriate \$97,000 to fund housing support services expansion; appropriate \$1,500,000 to fund increased housing program services from Emergency Shelter Grant proceeds. From the Real Estate Excise Tax II Fund appropriate \$398,666 to fund transfers in support of Howander Park and Lookout Mountain flood repairs. From the Public Utilities Improvement Fund re-appropriate \$3,475,500 for EDI loans and grants for Port of Bellingham's Rural Broadband Project, Bellingham Housing Authority's Samish Way Project, and City of Lynden's Front Street Project. From the Administrative Services Fund: appropriate \$40,000 in Facilities to fund increase in security screening services contract for the Courthouse; appropriate \$176,682 in Finance to fund increased staffing (2 FTEs) in support of the JD Edwards financial system upgrade from a project budget transfer; appropriate \$80,807 in Finance to fund a new Senior Purchasing Coordinator position. Ordinance introduced April 12, 2022. Full Council meetings begin at 6 p.m. (unless otherwise announced) in the Council Chambers at 311 Grand Avenue. 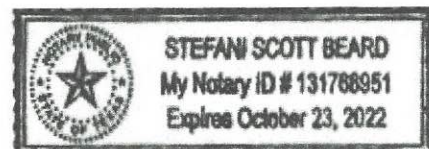
