#### **ACTION PROPOSED (INTRODUCED)**

The Whatcom County Council will consider adopting and may amend the following at its 6 p.m. meeting on May 27, 2025, or at a later date: ORDINANCE TO AMEND WHATCOM COUNTY CODE SECTION 3.08.100, COUNCIL APPROVAL REQUIRED, TO INCREASE THE THRESHOLD FOR CONTRACTS THAT REQUIRE COUNCIL APPROVAL (AB2025-264): This ordinance amends Whatcom County Code Section 3.08.100, Council Approval Required, to increase the threshold for contracts requiring Council approval from \$40,000 to \$75,000, add a requirement for Council approval of all interlocal agreements, and implement a quarterly reporting requirement. This ordinance was introduced on May 13, 2025. ORDINANCE AMENDING THE 2025 WHATCOM COUNTY BUDGET, REQUEST NO. 5, IN THE AMOUNT OF \$1,053,510 (AB2025-337): This ordinance amends the 2025 Whatcom County Budget as follows: From the General Fund: appropriate \$28,010 in Sheriff to fund full expenditure of WASPC RSO grant proceeds; appropriate \$213,000 in Sheriff to fund international border security patrols using grant proceeds; appropriate \$1,525 in Sheriff to fund the purchase of two handheld radars using grant proceeds; appropriate \$125,000 in Sheriff to fund firearm safety activities using settlement funds; appropriate \$200,000 in Health to fund Environmental Health enterprise permitting and licensing software updates using grant proceeds; appropriate \$3,175 in Non-Departmental to fund refugee stabilization services using grant proceeds. From the Countywide Emergency Medical Services Fund: appropriate \$327,800 in Non-Departmental to fund reimbursement of underpayment & underbilling in 2023-2024 to Stryker Corp. From the Real Estate Excise Tax I Fund: appropriate \$155,000 in AS-Facilities to fund minor remodel of Assessor's Office. This ordinance was introduced on May 13, 2025.

ORDINANCE AUTHORIZING INTERFUND LOANS TO FINANCE CASH
FLOW FOR COUNTY ROAD FUND UP TO \$4 MILLION FOR A TERM NOT TO EXCEED TWO YEARS (AB2025-355): This ordinance authorizes the Whatcom County Treasurer to make interfund loans from any eligible County Funds to the County Road Fund not to exceed \$4,000,000 per project and not to be for a term exceeding two years; Council must be notified regarding the loan


