ACTION TAKEN

The Whatcom County Council adopted the following at its March 25, 2025, meeting: **ORDINANCE (2025-014) TEMPORARILY AMENDING THE FUNDING LIMIT OF CASH FLOW LOANS FROM THE ROAD FUND TO NORTH LAKE SAMISH BRIDGE NO. 107 REPLACEMENT FUND-3905 FROM \$2,000,000 UP TO \$6,656,262.32 FOR A TERM NOT TO EXCEED TWO YEARS (AB2025-196)**: This ordinance temporarily amends the funding limit of cash flow loans from the Road Fund to the North Lake Samish Bridge No. 107 Replacement Fund-3905 from \$2,000,000 up to \$6,656,262.32 for a term not to exceed two years in order to ensure project completion. This ordinance was introduced on March 11, 2025. **ORDINANCE (2025-015) ESTABLISHING A PROJECT-BASED BUDGET FOR THE EAST WHATCOM REGIONAL RESOURCE CENTER SPORTS COURT (AB2025-211)**: This ordinance establishes a new East Whatcom Regional Resource Center Sports Court Project Fund with an initial budget of \$1,219,000 to support the development of a multi-use sports court in an underserved area in eastern Whatcom County. This ordinance was introduced on March 11, 2025. **ORDINANCE (2025-016) AUTHORIZING AN INTERFUND LOAN FOR THE CONSTRUCTION OF THE EAST WHATCOM REGIONAL RESOURCE CENTER SPORTS COURT (AB2025-212)**: This ordinance loans \$1,199,500 from the Public Utilities Improvement Fund to the East Whatcom Regional Resource Center Sports Court project budget, which shall be repaid by the project budget in full, no more than two years after the making of the loan. This ordinance was introduced on March 11, 2025. **ORDINANCE (2025-017) ESTABLISHING A PROJECT-BASED BUDGET FOR THE SILVER LAKE BOAT LAUNCH AT SILVER LAKE PART (AB2025-213)**: This ordinance establishes a new Silver Lake Boat Launch Renovation Fund with an initial budget of \$97,750 to account for revenues and expenditures associated with improvement of the Silver Lake boat launch ramp. This ordinance was introduced on March 11, 2025. **ORDINANCE (2025-018) AMENDING THE 2025 WHATCOM COUNTY BUDGET, REQUEST NO. 3, IN THE AMOUNT OF \$1,485,889 (AB2025-220)**: This ordinance amends the 2025 Whatcom County budget as follows: From the General Fund: appropriate \$8,400 in Superior Court Clerk to fund the continuation of the water rights grant for Clerk operations; appropriate \$150,000 in Planning and Development Services to fund the Birch Bay incorporation feasibility study; appropriate \$9,537 in Sheriff to fund 2025 Operation Stonegarden FY21 grant; appropriate \$4,392 in Sheriff to fund Organized Crime Drug Enforcement Task Force grant RL-23-0010; appropriate \$1,292 in Sheriff to fund Organized Crime Drug Enforcement Task Force grant RL-23-003; appropriate \$5,000 in Sheriff to fund Organized Crime Drug Enforcement Task Force grant RL-23-008; appropriate \$3,908 in Sheriff to fund Organized Crime Drug Enforcement Task Force grant RL-23-005; appropriate \$27,028 in Sheriff to fund Recreational Boating Safety grant; appropriate \$225,000 in Superior Court Administration to fund continuation of the water rights grant for purchase of JAVS system and related technology. From the American Rescue Plan Act Fund: appropriate \$113,100 in Non-Departmental to fund the Public Utilities District No. 1 broadband contract; appropriate \$0 in Non-Departmental to fund the Public Utilities District No. 1 broadband contract companion. From the Affordable Housing and Behavioral Health Fund: appropriate \$0 in Health to fund Jail and Juvenile behavioral health contracts. From Real Estate Excise Tax II Fund: appropriate \$97,750 in Non-Departmental to fund transfer out for the Silver Lake Boat Launch project budget; appropriate \$158,000 in Parks to fund the Maple Falls Community Park Roof Replacement project. From Real Estate Excise Tax I Fund: decrease appropriation of \$921,411 in Parks to fund the Parks Headquarters HVAC and Tenant Improvement project in the Public Utilities Improvement Fund. From Public Utilities Improvement Fund: appropriate \$19,500 in Non-Departmental to fund transfer out for the East Whatcom Regional Resource Center Sports Court project budget; appropriate \$1,208,911 in Parks to fund the Parks Headquarters HVAC and Tenant Improvement project. From Administrative Services Fund: appropriate \$249,882 in Administrative Services - Facilities to fund the Clean Buildings Performance Standards Compliance grant. This ordinance was introduced on March 11, 2025.

The Whatcom County Council will hold a public hearing, consider adopting, and may amend the following at its 6 p.m. meeting on April 15, 2025, or at a later date: **ORDINANCE ADOPTING AMENDMENTS TO WHATCOM COUNTY CODE SECTION 1.14, ELECTORAL PRECINCTS, WITH NEWLY ESTABLISHED VOTING PRECINCT BOUNDARIES FOR WHATCOM COUNTY (AB2025-231)**: This ordinance adopts and substitutes changes to the "Book of Election Precinct Maps" affecting Precinct 127, 128, 130, 601, 605, 609, 610, and 611 to reflect boundary line adjustments resulting from annexations in the city of Lynden; the revised Book of Maps is available through the Whatcom County Council Office and online through the Election page at the Whatcom County Auditor's Office homepage. This ordinance was introduced on March 25, 2025. **ORDINANCE AMENDING WHATCOM COUNTY CODE TITLE 20 (ZONING) REGARDING HOME-BASED BUSINESSES (AB2025-246)**: This ordinance amends Whatcom County Code Title 20 (Zoning) regarding home-based businesses and agritourism activities to consolidate the existing regulations for home occupations, cottage industries, agritourism activities, and occasional commercial use of non-commercial properties for hosting special events. This ordinance was introduced on March 25, 2025. **RESOLUTION TO DECLARE WHATCOM COUNTY REAL PROPERTY AS SURPLUS AND APPROVE TRANSFER (AB2025-234)**: Per RCW 36.34.130 and Whatcom County Code 1.10.340, and on the recommendation of the Whatcom County Property Management Committee, this resolution declares Whatcom County real property, tax parcel 380236 504432 0000 located on the north side of Wharf Street and the east side of East Pine Street within Bellingham, Washington as surplus and approves its transfer to the City of Bellingham for the appraised value of \$15,000 and all related closing costs. This resolution was introduced on March 25, 2025. **RESOLUTION TO SELL COUNTY TAX TITLE PROPERTY BY NEGOTIATION (AB2025-255)**: This resolution allows, per RCW 36.35.150(1)(a) and Whatcom County Code 1.10.340, and on the recommendation of the Whatcom County Property Management Committee, the sale of the following tax title property: Tax parcel number 380236 355201 0000 / PID 53682; BELLINGHAM BAY LAND CO'S 2ND ADD TO BELLINGHAM - ELY 16 FT OF THAT PTN OF BLK 115 LY WLY OF RR. The parcel would be sold by private negotiation to a governmental agency for a public purpose, for an amount not less than \$1000 to be paid in either cash, certified check, or money order to the Whatcom County Treasurer at the time of sale. This resolution was introduced on March 25, 2025.

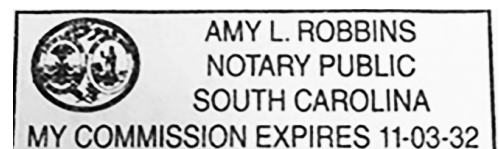
