**PAUL DAVIS HONORARY ON LUMMI ISLAND**

**WHEREAS**, Paul Davis has devoted forty-seven years to the service of Lummi Island as Treasurer of the Lummi Island Community Association; and

**WHEREAS**, Mr. Davis also served the Lummi Island Library’s, Friends of the Island Library as Treasurer for thirty years; and

**WHEREAS**, Mr. Davis produced the Island Newsletter, later named the Lummi Island *Tome* for decades, keeping residents informed of news and items of local interest; and

**WHEREAS**, Mr. Davis continues in his vital service editing and producing the *Brown Betty* electronic newsletter, apprising island residents of urgent and timely information of vital interest to them; and

**WHEREAS**, Mr. Davis has served as a cherished and respected supporter of the Beach Elementary School and the community at large for the better part of his life; and

**WHEREAS**, on March 7, 2023 the Lummi Island Community Association committed to create, install and maintain a sign for the central orchard space of the Ferry parking area. And the Whatcom County Public Works Department agreed to review and approve the style and placement of the sign; and

**WHEREAS**, on March 7, 2023 the Lummi Island Community Association committed to pay for the creation and installation of the roadway sign at the driveway entrance to the parking lot. And the Whatcom County Public Works Department agreed to create and install the sign in honorary road name design as stated in WCC 12.60.150.

1           **NOW, THEREFORE, BE IT ORDAINED** by the Whatcom County Council that the orchard area of  
2 the Lummi Island Ferry parking lot is given the honorary name of “Paul Davis Park”. Moreover, be it  
3 ordained the driveway of the parking lot is given the honorary name of “Paul Davis Parkway”.
