Amendment No. <u>3</u> Whatcom County Contract No. 201907038 CONTRACT BETWEEN WHATCOM COUNTY AND WHATCOM COUNTY FIRE PROTECTION DISTRICT 7

THIS AMENDMENT is to the Contract between Whatcom County and Whatcom Fire Protection District 7, dated August 8, 2019, and designated "Whatcom County Contract No. 201907038". In consideration of the mutual benefits to be derived, the parties agree to the following:

This Amendment allows for the addition of a "phase-in" Community Paramedic to begin training in late 2023 with the current Community Paramedic. This Amendment will pay for the wages and benefits of the new Community Paramedic, and part of the overtime costs incurred by the new Community Paramedic being removed from normal staffing. This transition will increase the maximum compensation by \$37,664 to \$941,716 for this five-year agreement from 2019 through December 31, 2023.

Unless specifically amended by this agreement, all other terms and conditions of the original contract shall remain in full force and effect.
