The Whatcom County Council adopted the following at its February 25, 2025, meeting: ORDINANCE (2025-005) ADOPTING AMENDMENTS TO WHATCOM COUNTY, CODE TITLES 20 & 22 TO ENACT SSB 5290 RE-GARDING LOCAL PROJECT REVIEW (AB2025-059): This ordinance adopts amendments to Whatcom County Code Titles 20 & 22 to enact SSB 5290 regarding local project review and fix some additional deficiencies in Title 22. ORDINANCE (2025-000) found critical upcoming consultant contracts including but not limited to owner's representative services, wetland mitigation consulting, geotechnical engineering, and traffic analysis, for a new project budget of \$10,816,280. This ordinance was introduced on February 11, 2025. ORDINANCE (2025-010) AMENDING THE 2025 WHATCOM COUNTY BUDGET, REQUEST NO. 2, in THE AMOUNT OF \$4,751,265 (AB2025-164). This ordinance amends the 2025 Whatcom County Budget as follows: From the General Fund: appropriate \$76,500 in Council to fund Professional Services for Investigative Committee; appropriate \$12,500 in District Court to fund Increases for Whatcom Dispute Resolution Center contract; appropriate \$52,509 in Executive to fund two vacant reclassified positions, companion to Supplemental #4888; appropriate \$22,500 in Health to fund recovery navigator in 2025 (Jan-July); appropriate \$72,100 in Health to fund substance Use Disorder professional with grant proceeds; appropriate \$20,000 in Non-Departmental to fund companion for Facilities Coordinator I, companion to #4887; appropriate \$47,100 in Non-Departmental to fund Companion for Facilities Coordinator I, companion to #4880 and #4889; appropriate \$47,100 in Non-Departmental to fund Office of Health Study from grant proceeds. From the Emergency Management Fund: appropriate \$353,853 in Sheriff to fund Bomb Cyclone 2024 Individual Assistance from grant proceeds. From the Behavioral Health Program Fund: appropriate \$679,750 to fund underspent 2024 Consolidated Homeless Grant proceeds. From the Behavioral Health Program Fund: appropriate \$81,420 to fund Coverdose Data Action 2025 program from grant proceeds. From the County Road gram Fund: appropriate \$81,420 to fund Overdose Data Action 2025 program from grant proceeds. From the County Road Fund: appropriate \$3,080 to fund road fund companion for ferry insurance, companion to #4872. From the Real Estate Excise Tax II Fund: appropriate \$85,000 in Parks & Recreation to fund Samish park Pedestrian Bridge Replacement; appropriate \$955,363 in Parks & Recreation to fund Van Zandt Community Hall Renovation. From the Real Estate Excise Tax I Fund: appropriate \$70,000 to fund reappropriation of Prosecuting Attorney tenant improvements. From the Public Utilities Improvement Fund: appropriate \$700,000 in Non-Departmental to fund Habitat Land acquisition; appropriate \$376,000 Improvement Fund: appropriate \$700,000 in Non-Departmental to fund Habitat Land acquisition; appropriate \$376,000 in Non-Departmental to fund Atwood Culvert replacement. From the Ferry System Fund: appropriate \$6,844 to fund ferry insurance increase, companion to #4873. From the Administrative Services Fund: record a labor pool request with a net \$0 expenditure in AS-Facilities Management to fund Facilities Coordinator 1 position; appropriate \$47,210 in AS-Facilities Management to fund Facilities Coordinator 1, companion to #4850 and #4890. From the Equipment Rental Fund: appropriate \$540,435 to fund Prisoner Transport. This ordinance was introduced on February 11, 2025. **ORDINANCE** (2025-011) AMENDING WHATCOM COUNTY CODE CHAPTER 2.123 FORESTRY ADVISORY COMMITTEE (MB2025-120): This ordinance amends Whatcom County Code 2.123 to revise the composition of committee membership, stagger-membership terms, and clarify the committee's scope of work. This ordinance was introduced on February 11, 2025.


