1a. Description of request:

Following a series of major rain events in 2018 and 2021, the LM 2000 Road bed needs repairs to maintain access. The road serves telecommunications towers and various recreational users. Due to mud and debris flows and a blocked culvert associated with the aforementioned storms, the road has been undermined in several locations This project will repair damaged sections of the road and include a spillway at the location of the referenced culvert to divert overflows during storm events minimizing erosion. ORD2024-050 established this project's budget and funds for construction of this project are a part of the current Seven-Year Capital Improvement Plan (ORD2024-058). This request also provides anticipated direct billing costs for Parks staff to administer the project and must be charged directly to the project. Parks also anticipates to be reimbursed by FEMA for 75% to 90% of the expenses of this project.

Companions to this supplemental are 4962 for parks special revenue fund 1800 contribution and 4937 for REET II fund 3240 contribution.

1b. Primary customers:

The LM2000 Road provides access to Lookout Mountain Forest Preserve to various user groups, including hikers, cyclists, and Parks staff, seeing roughly 40,000 visitors annually. The road also provides access to the telecommunications towers which support a variety of EMS, Federal Government, and other telecom services, for which the County is responsible for maintaining access to the towers located at the top of the mountain.

2. Problem to be solved:

The road is susceptible to failure in the locations outlined in this project. The county is responsible for maintaining the network of roads in the forest preserve. These road repairs are necessary to maintain access to the telecommunications towers per the county's various lease agreements.
