THIS AMENDMENT is to the Contract between Whatcom County and Dr. Tyson Hawkins, dated November 1, 2019 and designated "Whatcom County Contract #201911009". In consideration of the mutual benefits to be derived, the parties agree to the following:

This Amendment extends the term of this Agreement through December 31, 2022 and adds the following *Leave of Absence Clause*: "Contractor may request, in writing, a leave of absence without pay stating the date desired to begin and the date of return. During a Leave of Absence, the Contractor may, if he is able, attend medical meetings and advise medical staff remotely and will submit a monthly invoice with hours worked as per the original contract. In the event Contractor is unable to appear remotely, the County may endeavor to hire a locum tenens, with an addendum to the Physician's Contract that indicates the locum tenens agrees to be bound by the terms of the Administrative Physician's contract."

Unless specifically amended by this Agreement, all other terms and conditions of the original Contract shall remain in full force and effect.

This Amendment takes effect: January 1, 2022 regardless of the date of signature.


