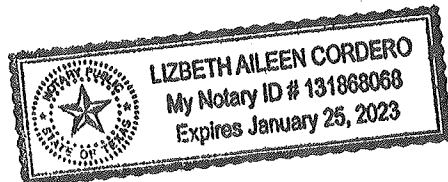
The Whatcom County Council will consider adopting and may amend the following at its April 21, 2020, meeting: **ORDINANCE AMENDING THE 2020 WHATCOM COUNTY BUDGET, REQUEST NO. 9, IN THE AMOUNT OF \$390,689 (AB2020-163):** This ordinance requests funding as follows: From the General Fund - \$128,500 for Health Department to fund substance use prevention program, \$21,748 for Sheriff to fund Fraternal Order of Police settlement, \$37,600 for Sheriff to fund public safety communications manager one-time costs, and \$91,962 for Sheriff to fund general fiscal year 2018 Operation Stonegarden program; from Homeless Housing Fund - \$32,627 for Health to fund increase in services from state consolidated housing grant proceeds; from the Public Utilities Improvement (EDI) Fund - \$100,000 to fund preliminary design of NW Annex redevelopment project. This ordinance was introduced on April 7, 2020. **ORDINANCE CLOSING LIGHTHOUSE MARINE PARK IMPROVEMENT FUND 362 (AB2020-164):** This ordinance would dissolve and close the 2015 Lighthouse Marine Park Improvement Fund 362 and its remaining cash balances return to the Real Estate Excise Tax II (REET II) Fund. This ordinance was introduced on April 7, 2020. **ORDINANCE AMENDING THE 2020 WHATCOM COUNTY BUDGET, REQUEST NO. 10, IN THE AMOUNT OF \$3,000,000 (AB2020-168):** This ordinance would appropriate \$3,000,000 to fund expanded COVID-19 emergency response services. This ordinance was introduced on April 7, 2020. **ORDINANCE AUTHORIZING AN INTERFUND LOAN TO FINANCE CASH FLOW FOR COVID-19 EMERGENCY RESPONSE (AB2020-169):** This ordinance would authorize the Whatcom County Treasurer to make an interfund loan from the Public Utilities Improvement Fund to the COVID-19 Emergency Response Fund for 1) refunding the emergency loan made in Ordinance 2020-015 and 2) for providing adequate cash flow for expanded COVID-19 response. The loan shall not exceed \$4,000,000 and shall be for a term not exceeding eighteen months, one-half percent interest shall be
