Background and Purpose

The purpose of this agreement is to continue the cooperative effort between the Whatcom County Sheriff's Office and USDA Forest Service to enhance State and local law enforcement in connection with activities on National Forest System (NSF) lands. The previous agreement (WC Contract # 201903039) expired December 31, 2023.

The Whatcom County Sheriff's Office will continue to provide one part-time deputy from the last signature date of this contract to December 31, 2029 whose primary assignment is to patrol the Mt. Baker-Snoqualmie National Forest inside the boundaries of Whatcom County, with particular attention given to those places utilized by the visiting public such as administered recreation sites, dispersed recreation sites, buildings and boat launching facilities. The USDA Forest Service will reimburse the Sheriff's Office for services provided.

Funding Amount and Source

This contract is for \$34,056.00. Added to the original contract of \$22,704.00, makes a total for 2024 of \$56,760 to be provided by USDA Forest Service.
