Please describe your occupation (or former occupation if retired), qualifications, professional and/or community activities, and education	My mix of professional experience, along with being a member of the LGBTQ+ community, makes me a uniquely qualified candidate to serve on Whatcom County's Public Health Advisory Board. Though I've lived in Whatcom County since 2012, I've been employed by King County in a variety of increasingly responsible positions over the last 27 years. For the last six years I have been the Director of Special Projects for the King County Executive. Prior to my current role, I was a Strategic Advisor in the Behavioral Health Division of King County's Department of Community and Human Services. I also served as a Principal Legislative Analyst for the King County Council for close to eight years. I received my master's degree in public administration from Seattle University in 2005. Through my policy and project management work, I bring deep understanding of public health and human services and criminal legal systems to the Whatcom County Public Health Advisory Board. I understand the meaningful and challenging work of public health systems, as well as the community and financial components that influence and impact services.
10. Please describe why you're interested in serving on this board or commission	As a member of the LGBTQ+ community and a former employee of an AIDS service organization in Seattle (Chicken Soup Brigade - now Lifelong) during the AIDS crisis, I know first-hand how important public health is to my community. I want to ensure LGBTQ+ voices are involved in helping policymakers understand the impacts of their decisions. I started my public service career in Public Health-Seattle and King County (PHSKC) in 1994 as a receptionist in the Prevention Division before moving up the career ladder to my current position today within the King County Executive's Office as the Director of Special Projects. Serving as the lead staff for the King County Council's Law, Justice, Health, and Human Services Committee and lead budget staff overseeing health and human services budgets for several years, I am deeply familiar with the issues facing our public health system. As the Executive's government relations liaison for Harborview Medical Center, which is owned by King County and operated by UW Medicine, I understand how community, particularly those living unhoused or with behavioral health conditions rely on safety net health systems and organizations, to meet their vast health needs. My master's degree in public administration from Seattle University continues to shape how I view public service in the context of social justice. I've lived in Whatcom County for over ten years and want to contribute my lived experience, skills, and abilities to my home community – and public health is the heart of the community.
