The Whatcom County Council will have a public hearing, consider adopting, and may amend the following at its July 7, 2020, 6 PM meeting, or at a later date. **ORDINANCE FINALIZING A REVISED SYSTEM OF ASSESSMENT FOR DRAINAGE IMPROVEMENT DISTRICT NO. 5 (AB2020-064)**: This ordinance adopts a revised system of assessment to provide revenue for Drainage Improvement District No. 5. The revised system of assessment is similar to the current system but is based on more accurate base mapping and utilizes automated routines to reduce the potential for errors. The District Supervisors set the final assessment amount to be collected for the district. Council introduced above at its February 11, 2020, meeting. 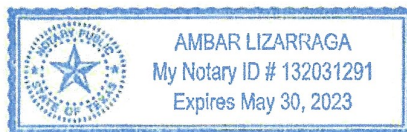
