Response to Question 10

I was a Public Defender for more than 30 years in Superior Courts in Yakima, Benton, Franklin and Grant Counties. I served as the director of public defense for two different county offices, one of which served two counties. I have extensive experience in jail systems, working directly with clients, jail personnel, professional staff and law enforcement.

I provided direct services to clients seeking release or reduced bond conditions, admission to specialty courts such as drug court or DUI court; criminal trial processes; and interactions with various offices in the jails. I am familiar with the physical limitations and other considerations when working with in-custody clients, combative persons, drug and alcohol-affected clients and those with active mental health issues. I also worked for the state Office of Public Defense, helping counties develop public defense systems and procedures.

I graduated from Gonzaga University School of Law in Spokane in 1986, where I was a Thomas More Scholar, then clerked in Division II of the State Court of Appeals in Tacoma for one year. I then practiced in Yakima for three years, working for the law firm that represented, among other clients, the Yakama Indian Nation. From there, I went to the Yakima County Department of Assigned Counsel where I remained for more than 15 years.

After leaving Yakima County, I worked for the state Office of Public Defense in Olympia then left to start the Benton-Franklin Office of Public Defense in Kennewick. From there I went to Grant County and started the Grant County Office of Public Defense. I continued as director and as a felony contract defender for eight years. Rather than retiring, I transitioned from full-time felony public defense work to representing mentally ill clients in Involuntary Treatment Act (ITA) proceedings in Yakima County. That representation involved clients detained in designated mental health facilities and continued until I fully retired at the end of 2021.

I served on active duty in the U.S. Marine Corps from 1969 to 1972. I received my BA from Central Washington University in Ellensburg where I majored in Journalism and Ethnic Studies. Prior to law school, I worked in journalism and corporate communications.
