

DARK FIBER ORDER
Multiple Fiber Routes

This Dark Fiber Order: Multiple Fiber Routes (this "Service Order") is entered into as of the date of last signature below (the "Effective Date"), by and between ASTOUND BUSINESS SOLUTIONS, LLC, a Delaware limited liability company, acting on behalf of itself and as agent for its Affiliates (collectively, "Provider"), and WHATCOM COUNTY, a political subdivision of the State of Washington ("Customer"). This Service Order is made pursuant to and will be governed by that certain Master Services Agreement between Provider and Customer dated October 26, 2023 (the "MSA"). All capitalized terms used but not defined in this Service Order shall have the meanings given to them in the MSA.

Section 1: Termination of Old Contracts. Provider, as successor in interest to Wave Business Solutions, LLC, and Customer are the parties to the following contracts (collectively, the "Old Contracts"): (i) that certain Dark Fiber Order dated July 30, 2018; (ii) that certain Dark Fiber Order: Multiple Fiber Routes dated November 28, 2018; (iii) that certain First Amendment to Dark Fiber Order: Multiple Fiber Routes dated March 13, 2019; (iv) that certain Second Amendment to Dark Fiber Order: Multiple Fiber Routes dated May 31, 2022; and (v) that certain Order for Dark Fiber Services dated February 23, 2023. The Parties now intend for this Service Order to replace and supersede the Old Contracts in all respects. Accordingly, as of the Service Commencement Date for the Services under this Service Order, the Old Contracts shall terminate and have no further force or effect; provided, that any outstanding payment obligations under the Old Contracts shall survive until met.

Section 2: Description of Fiber Routes and Charges. Provider shall deliver to Customer the dark fiber services set forth in the following table (each, a "Service," and collectively, the "Services"). The Services shall connect the end points set forth below (each such connection, a "Fiber Route"), using the number of dark fiber strands described below, in exchange for the one-time, non-recurring installation cost ("NRC") set forth below, and the monthly recurring charges ("MRC") set forth below:
