As the fiscal, economic, and energy policy advisor to the Speaker of the Arizona House of Representatives, negotiated fiscal solutions to close the State's chronic multi-billion 2009-11 budget deficits and communicated these with media, government, and public audiences. This required working extensively across stakeholder groups including industry associations, unions, the Senate, and the Governor's Office to achieve lasting reforms. Managed staff, edited multiple appropriations and budget reconciliation bills, drafted talking points, fact sheets, and provided written and oral testimony to legislators, the Governor's office, trade, and advocacy groups.

Authored legislation on behalf of the Speaker to lower the tax and payroll costs of capital-intensive "base industries" relocating to, or making new investments in, the state, particularly those in the energy and mining sector, to create a competitive environment for the industry. This required acquiring and analyzing business relocation data and surveys, utilizing input-output models to determine the fiscal and economic impact of proposals, drafting the legislation, and leading the media engagement strategy, finally presenting the bill and its underlying research to legislators, the executive branch, external stakeholders, and the public.
