Committee Discussion and Recommendation to Council

1. AB2021-252 Resolution approving recommendations on eight applications for Open Space Current
Use Assessment

Joshua Fleischmann, Planning and Development Services Department, gave a presentation and answered questions on individual properties, how long it takes to get this many applications, whether wetlands are protected from development automatically, public access, how many acres are currently in the open space program, how much taxes have been shifted to the rest of the population as a result of the program, whether the ordinance would have to be amended if the Council just approves properties that both staff and the Planning Commission said yes to, reasons for denials, the farm and agricultural subclassification of open space lands, whether applicants asked for a change voluntarily, and the threshold or dollar amount one has to generate to qualify for the farm and agricultural open space classification.

Donovan moved to recommend to the full Council that they accept the five properties that have favorable recommendations from both staff and the Planning Commission. The motion was seconded by Browne.
