Councilmembers discussed the need for industry and the community to continue talking, that this could be viewed as a temporary fix to get through the Comprehensive Plan update, that limiting HII affects the entire county and not just one neighborhood, concerns about clarity of the language, and that the intent is that if something is not in the prohibited list it is an allowable heavy industry use in this zone.

Cliff Strong, Planning and Development Services Department, stated the code says (in a different area) that all the existing permitted uses in HII would still be allowed and all the permitted uses in LII would also be allowed.

Councilmembers spoke about how restricting HII property zoning impacts industry and Whatcom County as a whole, that this seems to be a compromise and has brought a lot of community engagement, that there are not proposed projects in the area right now that they are pulling the rug on, and that this code language does not identify other areas where this type of use will be done.

They discussed whether the enabling ordinance would also need to be amended, and whether they could make further changes to the membership to add people with lived experience.
