NOW, THEREFORE, BE IT ORDAINED by the Whatcom County Council that (the IPRTF/LJS will):

## SECTION 5 - INTERJURISDICTIONAL AND STAKEHOLDER COORDINATION:

If this sales and use tax is approved by the voters:

- 5.2. The chair(s) of the IPRTF/LJS will be Finance Advisory Board members to oversee and make recommendations on funds collected and operations of the jail and behavioral health facilities.
- 5.3. Advise the County and cities on policy matters related to law and justice.

Participate with the Health Department in the local Community Health Improvement Plan process to create a public health and safety component of the Community Health Assessment.

Establish a Justice Project Oversight and Planning (JPOP) Committee that includes a balanced membership ensuring fair representation of BIPOC communities, service providers, and people with lived experience.

<u>Reporting</u>: With guidance from the JPOP Committee, coordinate with the Finance Advisory Board to monitor the progress of the Implementation Plan:

Annual progress report on Plan goals

Recommend plan updates a minimum of every five years.

Advise the Whatcom County Council and Whatcom County Executive on the appropriate level of resources needed for the IPRTF/LJC to fulfill its planning, community consultation, and oversight charge.

Consult with the BIPOC Community, Racial Equity Commission, people with criminal justice lived experience, and service providers:

- 5.4. Evaluate representation the IPRTF/LJC membership. Update membership, as needed, to ensure adequate representation.
- 5.5. Evaluate the progress of the Implementation Plan and future planning efforts, particularly related to data gathered on racially disparate impacts in the Whatcom County criminal justice system, and recommendations regarding elimination of barriers to public participation.

#### SECTION 7 – INCARCERATION PREVENTION AND REDUCTION INVESTMENTS:

7.2 Work with the County Executive to maximize resources, build capacity, and align plans in order to accomplish projects.

#### SECTION 8 -SUBSEQUENT IMPLEMENTATION PLANS AND IMPLEMENTATION PLAN AMENDMENTS:

## Reporting:

• 8.1 Every two years, coordinate with the County Executive to update the Implementation Plan with a detailed Spending Plan for the public health, safety, and justice tax, that adheres to the terms of this ordinance. The spending plan may not impede the County's ability to pay debt service on facility bonds issued against the tax.

- 8.2 Every five years, the Whatcom County Executive shall coordinate with the IPRTF/LJC and Finance Advisory Board to update the Justice Project Implementation Plan based on an analysis of data collected, measurements for outcomes and efficacy of the current Plan, and in alignment with a population health report such as the Community Health Assessment, as well as cost estimates, timelines, and gaps in resources needed to reach community health targets. The IPRTF/LJC shall transmit the Implementation Plan to the Whatcom County Council for approval.
- 8.3 Ensure plans comply with Section 3 Sales and Use Tax Purpose and do not impede the County's ability to pay debt service on facility bonds issued against this tax.

## SECTION 9 – OVERSIGHT, ACCOUNTABILITY, AND TRANSPARENCY:

9.1 Monitor progress toward the goals of the Justice Project Implementation Plan and

<u>Reporting</u>: Annual written and oral report to the Finance Advisory Board and Whatcom County Council. This report shall:

- Detail steps taken to achieve the goals of the Implementation Plan;
- Assess progress toward goals;
- Review resources needed to further meet goals
- Recommend any necessary updates to the Implementation Plan and/or Spending Plan.
- 9.2 <u>Reporting:</u> Receive annually from the Finance Advisory Board a written and oral report on the financial performance of the fund and associated programs, to include:
  - Detail of fund revenue;
  - expenditures by Implementation Plan project;
  - resources beyond this sales and use tax invested in Implementation Plan projects;
  - additional resources needed to further meet goals;
  - recommendations for any updates to the Implementation Plan and/or Spending Plan.
