As you'll see, both letter writers voice concern about the current structure of the Health Department Board. A key theme is that most residents are unaware that the County Council serves as the Health Board, and when they learn this, they believe the structure should change.

While anecdotal, my own conversations confirm this disconnect. Over a couple of days, I randomly "button-holed" more than 35 people on the street in Bellingham, Blaine, and Birch Bay and asked first if they lived in Whatcom County. Of the 31 who did, not one of them knew who sits on the Health Board. When I explained that it was the County Council, people were surprised, even alarmed -- and all responded that it should be reconfigured. A number of them went further, saying that if a council member opposed reform, it would affect their vote in the future

Of course, most residents don't base their decisions on a single issue. That said, questions of public health and community well-being are weighty matters, and it is clear that many constituents feel strongly about how those responsibilities are handled.

Thank you for taking the time to consider these concerns. I sincerely hope that you decide to support a change to the Health Board's composition, because all signs suggest your constituents want and expect it.

Shockingly, the board consists only of elected county council members. There are no medical professionals among its seven members. This arrangement isn't common knowledge. That's a problem. When such a crucial body operates without public awareness or debate, residents can't weigh in on how it's structured or whether it has the right expertise. The lack of knowledge of who's on the Board of Health means the public hasn't had a real chance to ask if we're doing this the best way possible.

Our council members work hard for the community, but health policy is complex, requiring specialized knowledge in medicine, epidemiology, and public health management. In emergencies — pandemics, water contamination, disease outbreaks — we depend on decisions grounded in science and experience. Without trained experts at the table, we risk decisions made without the very insights that could save lives.

As you'll see, both letter writers voice concern about the current structure of the Health Department Board. A key theme is that most residents are unaware that the County Council serves as the Health Board, and when they learn this, they believe the structure should change.

While anecdotal, my own conversations confirm this disconnect. Over a couple of days, I randomly "button-holed" more than 35 people on the street in Bellingham, Blaine, and Birch Bay and asked first if they lived in Whatcom County. Of the 31 who did, not one of them knew who sits on the Health Board. When I explained that it was the County Council, people were surprised, even alarmed -- and all responded that it should be reconfigured. A number of them went further, saying that if a council member opposed reform, it would affect their vote in the future.

Of course, most residents don't base their decisions on a single issue. That said, questions of public health and community well-being are weighty matters, and it is clear that many constituents feel strongly about how those responsibilities are handled.

Thank you for taking the time to consider these concerns. I sincerely hope that you decide to support a change to the Health Board's composition, because all signs suggest your constituents

Dear County Council members. I really appreciated the opportunity to attend the townhall meeting held at the Deming library last week. Although I am not aware of all of the protocols that the council has for conducting these community meetings I am hoping that you can discourage the spread of misinformation. The reason that I am writing to you is that after Councilmember Byrd's discourse of the possible restructure of the Health board two of my friends who attended approached me for clarification.

Despite the comments that there would be uneven representation of elected vs non-elected members RCW 70.05.030 is very clear that this is not the case (j) The number of members selected under (a) and (e) of this subsection **must equal the number of city and county elected officials** on the board of health ((a) states the categories of non-elected members and (e) designates tribal representatives). I think there was a misdirect when it was indicated that the number of appointed (non-elected) had to exceed the number of electeds. The comment from the audience about Snohomish Co now regretting their restructure could certainly be related to their error in this calculation and the haste that they may have assembled their board.

Regarding the performance of the Council during the COVID pandemic that was discussed during the townhall, I think the report commissioned by Council speaks for itself: Whatcom County COVID Review: The Berk Report 2022: page 20 states that "All operational personnel interviewed cited County councilmembers' participation in and presence at the WUC (Whatcom Unified Command) as disrupting the functioning of WUC as a whole".

Pages 28-29 outline the Recommendations to the County Council and one of these recommends to "include councilmembers in training and exercises and provide training on crisis communications. Expand the membership of the Health Board to include members with public health expertise and representatives from cities within the county. Ensure all participants in a response effort are working within a unified structure toward common goals."

Recommendation #12: A Health Board with members representing a wider diversity of professions and perspectives would enhance its functioning during a health emergency. (This addresses the complexity of the Council's role as both the Health Board and Council.) I know that some of the councilmembers who were present during the emergency phase of the pandemic are no longer on council but I don't think bringing up that "they are all opposed to a restructure" was an appropriate comment during the meeting. There are some very clear action steps for county leadership in this document and I am hopeful that they are being addressed for future emergencies. If you have not read this document, I encourage you to do so.

Page 25 outlined one role of PHAB and it appears that members were instrumental in the development and implementation of the Employer Support Taskforce. This appeared to be successful but is one small part of how this advisory group can help. As I mentioned in the townhall, your PHAB has made the recommendation to restructure the Health Board by a unanimous vote. Please respect the time and effort that has gone into this recommendation.

As I stated in the first paragraph, I am not aware of rules of conduct for townhall meetings. My hope in sharing this email with you is that you will honor your role as leaders when you dialogue with your community and restrain from a discourse of misinformation. It really is okay to say you don't know and will get back to folks. We respect this. There is already too much distrust in our communities and giving false information to make a point just leads to an "us vs them" mentality. We are all in this together.

I submit this as a public comment in support of reconfiguring the WC Health Board:

The creation of the Governors' Public Health Alliance by fifteen Democratic governors and Guam provides a timely and persuasive validation for restructuring Whatcom County's Health Board to include public health professionals and scientific advisors alongside elected officials. The alliance demonstrates that in times of destabilized federal health leadership, science-based collaboration and decentralized expertise are essential to maintaining community health resilience.

Just as states formed a multistate alliance to restore science-driven leadership amid federal uncertainty, Whatcom
County faces similar vulnerabilities if its Board of Health remains composed solely of elected council members without formal medical or public health expertise.
Both efforts arise from the same imperative: when top-down guidance becomes politically compromised or insufficient, localized, expert-informed governance becomes

the most reliable safeguard for community health and public trust.

The Governors Public Health Alliance has explicitly prioritized real-time disease surveillance, vaccine coordination, and joint emergency response, functions that require technical understanding and professional continuity. Whatcom County's Public Health Advisory Board (PHAB) already includes professionals from various fields, including medicine, epidemiology, housing, and social determinants of health; yet, as the 2025 joint working group concluded, excluding these voices from the decision-making process of the Board of Health itself creates a structural blind spot in crisis response capacity.

Interview evidence gathered by Whatcom's own structural review shows that counties combining elected and non-elected expertise make fairer, faster, and less politicized health decisions, especially during pandemics. The federal retreat from science-based coordination under HHS Secretary Robert F. Kennedy Jr. further underscores this: if science becomes contested at the national level, local boards insulated from ideological swings can ensure continuity of rational, protective health measures.

The Governors Alliance also emphasizes inclusion—linking diverse state populations through shared expertise and pooled resources. Similarly, an expanded Whatcom Health Board could strengthen community legitimacy and transparency, incorporating input from tribal partners, health care systems, and vulnerable populations, supporting broader public compliance and trust during crises. In essence, the Governors Public Health Alliance reflects the same rationale that should guide Whatcom County: when higher levels of government falter, empowered local health governance rooted in professional expertise becomes essential. Reconfiguring the county's Board of Health to include scientific and medical members would align Whatcom's local strategy with the evidence-based, collaborative model now being adopted at the state level across the United States.

Please refer to Recommendation #12 in the **BERK REPORT**, which was commissioned to assess Whatcom County's handling of the Covid-19 crisis.

Whatcom Covid response.

Recommendation #12, as you see, speaks to the wisdom of expanding the Health Department Board before the next public health crisis hits us.

The BERK Consulting report commissioned by Whatcom County after the COVID-19 response made it clear that our community has much to learn from recent public health challenges. Among its most important findings is Recommendation #12, which calls for reconfiguring the Health Board to better reflect the range of experience and perspectives essential to effective leadership in future health crises.

The report rightly notes that "a Health Board with members representing a wider diversity of professions and perspectives would enhance its functioning during a health emergency." This recommendation speaks to what our county experienced firsthand during the pandemic: decision-making constrained by limited professional diversity and blurred lines between political and public health roles. A stronger, more balanced Health Board is fundamental to improving our readiness and our unity in the face of the next crisis.

Including members with public health and medical expertise—those who understand epidemiology, emergency management, hospital coordination, and community impacts—will help the Board maintain focus on evidence-based decisions. **Moreover, involving city representatives from Bellingham and other municipalities acknowledges that health emergencies do not stop at jurisdictional boundaries.** Collaboration among local governments should be built into the Board's structure, not left to ad hoc partnerships. I would think that Council members representing our smaller communities would want to support the reconfiguration -- after all, those communities are your friends, family, and neighbors who you want to love and protect.

As for Council member Kaylee Galloway, who has still not made up her mind, I would urge her to support the reconfiguration for similar reasons. In the next election cycle, you may not be unopposed in your campaign.

This should not be a political or a power issue -- it is a common-sense, common good decision.

As BERK's analysts found, distinguishing the roles of the Health Board and the County Council will promote clearer accountability and communication. A reconfigured Board that values diversity of skill, perspective, and representation will make Whatcom County more resilient and better prepared for future public health emergencies.

I urge the Council to prioritize the full implementation of Recommendation #12—expanding and reconfiguring the Health Board to reflect professional expertise and community diversity. The lessons we've paid for through hardship and loss during COVID-19 should guide a stronger, more responsive public health system.

Here is how the Berk Report phrased Recommendation #12:

Recommendation $\#1\overline{2}$:

Health Board Role and Membership

During the pandemic period, the Whatcom County Council fulfilled its responsibilities as both the Council and the Health Board. During this time, it was not clear that the members of Council fully understood the separation of their duties as it pertained to each of their roles. The roles of the two organizations are different. While the Health Board has specific approval roles for some decisions made by the Health Officer, there were times when its decision making may have interfered with what is traditionally the role of the executive branch of government. The County must change the membership of either its Health Board or its PHAB to comply with recent updates to state statute. This presents an opportunity to expand the membership of the Health Board to both add public health and/or medical expertise and create a governing body with a different makeup from the County Council.

Recommendation #12:

A Health Board with members representing a wider diversity of professions and perspectives would enhance its functioning during a health emergency. Having members with public health and/or medical expertise could help keep the focus on public health issues. Members can also hear from peers on the Board rather than only County staff. Further, changing the composition of the Health Board could help distinguish the roles of that entity and the County Council. The County Council should also consider expanding or reconfiguring the elected members of the Health Board. It may be desirable to add or replace some County elected positions with elected officials from the City of Bellingham or other municipalities within the county. The number of elected officials may not be greater than the number of non-elected members, so the Council should be mindful of the total size of the Board.
