8 9	<b>WHEREAS,</b> RCW 36.34.005 authorizes counties to establish comprehensive procedures for the management of county property, including the sale of surplus real estate where it is found to be in the				
10	best interest of a county to sell same; and				
11	best interest of a county to sen same, and				
12	WHEREAS, in Whatcom County Code (WCC), Chapter 1.10, Whatcom County has established				
13	those procedures; and

15	WHEREAS, Whatcom County owns a property located on Jenson Road and Agate Bay Lane; and

17	WHEREAS, there are limited records on this property but they indicate that the property has				
18 19	been owned by Whatcom County since the early 1900's; and				
20	WHEREAS, the property has no utility to Whatcom County; and				
21	WILLIAM IS, the property has no utility to Whatcom Country, and				
22	WHEREAS, the City of Bellingham has interest in ownership of the property to support an				
23	acquisition of adjacent property that is located in the Lake Whatcom watershed and Whatcom County has				
24	interest in transferring the property to the City of Bellingham to support their watershed acquisition; and

26	WHEREAS, an appraisal was completed and the property was valued at \$15,000; and				
27 28	WHEREAS, WCC 1.10.340 allows for a transfer of property to a governmental agency without a				
29	public sale; and

31	WHEREAS, RCW 36.34.130 allows for transfer of property from a County to another				
32	governmental agency by means of private negotiation upon such terms as may be agreed upon and for				
33	consideration as may be deemed to be adequate; and

36 37	considered Whatcom County's best interest, recommends that the County Council declare Whatcom				
38	County real property, tax parcel number 380419 006520 0000, to be surplus property and that the property be transferred to the City of Bellingham upon payment of the appraisal value of \$15,000 and all				
39	related closing costs.
