ACTION TAKEN

The Whatcom County Council adopted the following at its March 9, 2021, meeting: **ORDINANCE (2021-009) REGARDING TEMPORARY INSTALLATION OF STOP SIGNS ON MARSHALL HILL ROAD (AB2021-115)**. This ordinance allows for the installation of stop signs and is necessary to comply with RCW 46.61.200 and RCW 47.36.110 to install traffic control signs. Due to recent severe weather and heavy rains a portion of Marshall Hill Road experienced a fill stop failure, requiring a one lane roadway configuration with the stop control at each end. This ordinance was introduced on February 23, 2021.

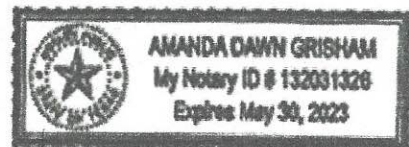
