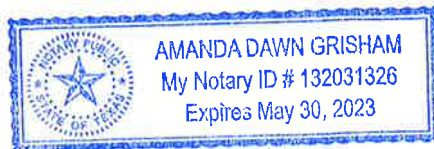

The Whatcom County Council will have a public hearing, consider adopting, and may amend the following at its July 21, 2020, 6 PM meeting, or at a later date.

**RESOLUTION AUTHORIZING THE COUNTY EXECUTIVE TO ENTER INTO A TWENTY-YEAR COMMUNICATION TOWER LEASE AGREEMENT WITH CELLCO PARTNERSHIP d/b/a VERIZON WIRELESS (AB2020-253):** This Resolution authorizes the County Executive to enter into a twenty-year communication tower lease agreement with Cellco Partnership d/b/a Verizon Wireless for leased space on park property located at the Lookout Mountain Forest Preserve as outlined in the agreement. Council introduced above at its July 7, 2020 meeting.

**RESOLUTION AUTHORIZING THE COUNTY EXECUTIVE TO ENTER INTO A TWENTY-YEAR COMMUNICATION TOWER LEASE AGREEMENT WITH PI TOWER DEVELOPMENT LLC (AB2020-254):** This Resolution authorizes the County Executive to enter into a twenty-year lease with PI Tower Development LLC for tower lease sites located on Lookout Mountain and are remote and do not impede or impact public recreation. Council introduced above at its July 7, 2020 meeting.
