Background

Council began discussions on the Comprehensive Plan in June, 2024. Since then, the Council has held several meetings, including joint Planning Commission meetings and Whatcom County Elected Officials meetings. Planning and Development Services officially transmitted the Planning Commission's recommended draft Comprehensive Plan to the County Council on February 10, 2026.

The Comprehensive Plan is scheduled for public hearing and final action on July 14, 2026.
