



Dear Executive Sidhu:

As current Chair of the Whatcom County Library System (WCLS) Board of Trustees and a member of the library board Personnel Committee, I am in the unique position of interviewing candidates to be my replacement for Position #3 when my second term ends at the end of January 2026. This month, trustee John Miller and I met with several candidates and were extremely impressed with one candidate in particular, J. Riley Sweeney. Today the WCLS Board voted unanimously to recommend that he be appointed to Position #3, effective February 1, 2026.

Mr. Sweeney has been a longtime library user and WCLS partner for many years. When he worked for the City of Ferndale, Mr. Sweeney collaborated with WCLS on promotional efforts related to our "I Believe in Libraries" campaign. This won a national award from the American Library Association! He understands marketing and public relations and has a deep appreciation for the challenges to intellectual freedom that libraries face. He and his family use the library weekly (sometimes daily). He's active in the Meridian School District, one of WCLS's ConnectED partners. He lives in a geographic area of Whatcom County that is not otherwise represented by other trustees. He writes plays for the Lynden Heritage Museum, another WCLS partner. He has proven experience with community outreach, which will be essential to us as we begin our next strategic planning process. He's articulate, passionate about libraries, and understands public service. We are excited by the energy he will bring to our board.

If approved, J. Riley Sweeney's first term on the WCLS Board of Trustees would run through January 31, 2030.
