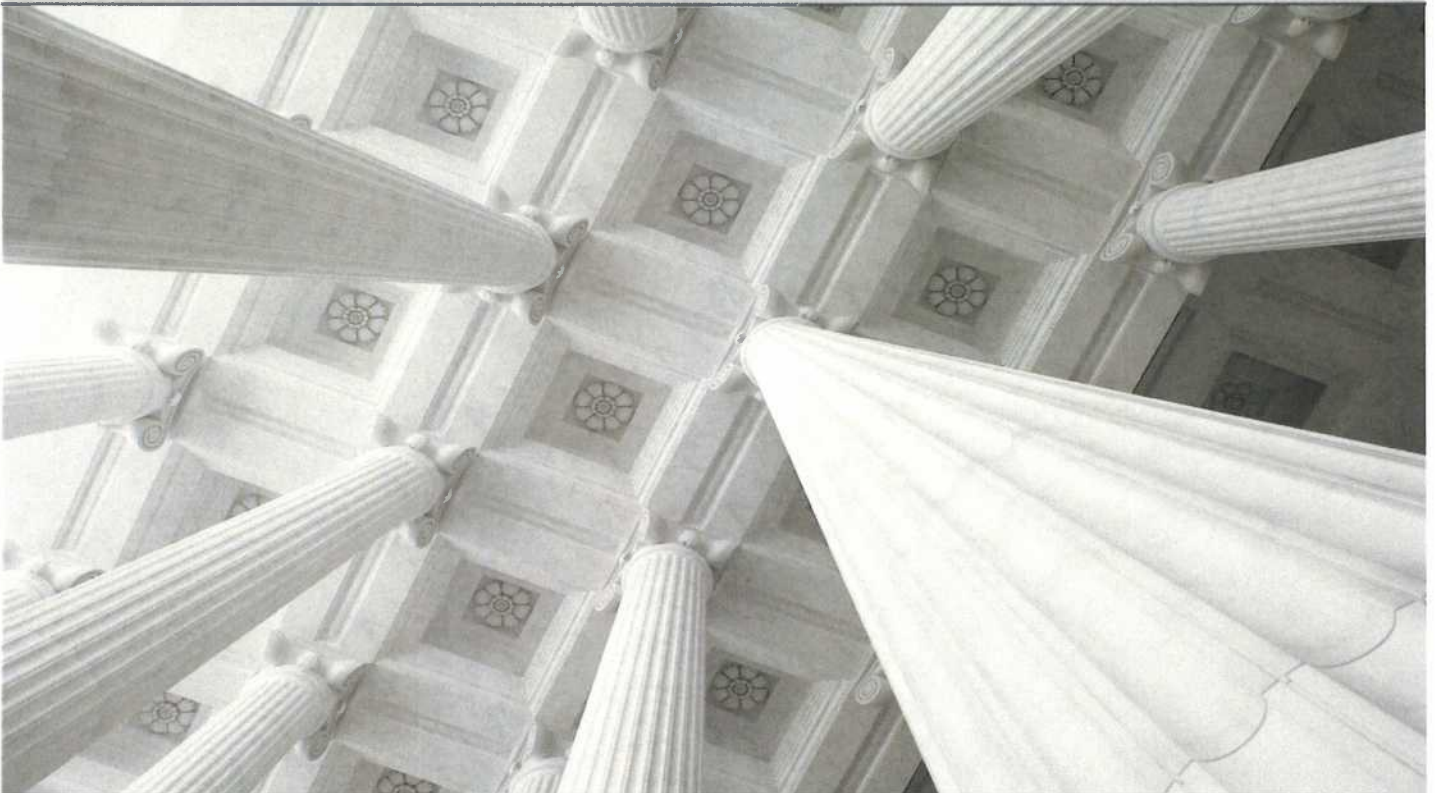

Per Rusty Noble, AS Associate Manager Whatcom County Facilities "... a subcontractor will install all required blocking, conduits, then pull wire since you (JAVS) are not licensed." A system drawing will need to be prepared, with the quote, for facilities to use when they bid out the project. "I will need to know all locations wires will need to be pulled to like mics monitors, cameras, tv's, etc. In order for the general contractors to bid this portions of the project."
