WHEREAS, Administrative Services has provided a list of checks that were issued prior to July 1, 2022 but never presented;

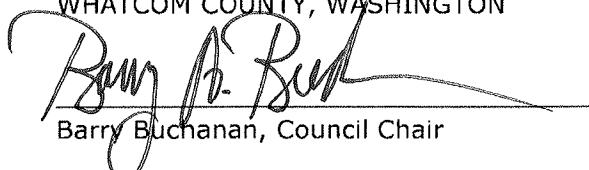
